### **ARTICLE I- RECOGNITION CLAUSE**

This Agreement is entered into by and between the Village of Caledonia, hereinafter referred to as the "Village", or "Employer", and the Village of Caledonia Highway Department Employees Association, hereinafter referred to as the "Association". The Village recognizes the Association as the sole and exclusive bargaining agent for all regular part-time and regular full-time employees of the Highway Department.

#### **ARTICLE II- WAGES**

Effective January 1, 2022, Full Time Employees Across the Board with Caledonia shall receive an increase in total wages applied as a 2.0% increase as follows:

Full-Time Employees	2021	1-1-2022 (ACB)
Start (base rate)	21.70/hr.	22.13/hr.
After 1 year	24.95/hr.	25.45/hr.
After 2 years	27.08/hr.	27.62/hr.
After 3 years	29.86/hr.	30.46/hr.

### **ARTICLE III- DURATION**

This agreement shall become effective when signed and shall remain in full force and effect January 1, 2022 through December 31, 2022.
