**A RESOLUTION AUTHORIZING THE PAYMENT OF CLAIM  
FOR ANTWAUN JACKSON-TURNER**

The Village Board for the Village of Caledonia, Racine County, WI do resolve as follows:

**WHEREAS**, on November 11, 2024, Antwaun Jackson-Turner submitted a claim in the amount of \$2,000.00, attached hereto as **Exhibit A**, requesting reimbursement for replacement of his glasses. In verifying the amount of the claim, it was determined that the actual replacement cost for the glasses was the amount of \$2,100.00. See attached receipt for the replacement of the glasses, attached hereto as **Exhibit B**.

**WHEREAS**, on December 10, 2024, the Committee of the Whole recommended that the Village resolve this claim by paying for the replacement glasses from Tower Optical for Antwaun Jackson-Turner in the total of \$2,100.00 upon the execution of a release in exchange for the settlement of the claim with the agreement that this settlement is the compromise of a disputed claim and that the payment of said amount is not to be construed as an admission of liability upon the part of the Village of Caledonia, any of its departments and/or employees with liability being expressly denied; and

**NOW, THEREFORE, BE IT RESOLVED** by the Caledonia Village Board, that the recommendation of the Committee of the Whole is hereby approved, and such claim shall be resolved by paying for the replacement glasses from Tower Optical for Antwaun Jackson-Turner in the total of \$2,100.00 upon the execution of a release in exchange for the settlement of the claim as set forth above.
