Project Overview

Due to the pavement life, the Wisconsin Department of Transportation (WisDOT) is planning to resurface WIS 32 from 1400' north of 4-Mile Rd to 800' south of E. County Line Road in the Village of Caledonia and Racine County. As part of the project, plans are being developed to upgrade the signals at Middle Road.

No work is expected in the exception area—the segment of WIS 32 which was recently constructed in 2019 (see Map next page).

Proposed Improvements

- Mill 4" of existing pavement repave with 4" asphaltic pavement
- Pave shoulders to 5-foot-wide, where possible.
- Re-dress gravel shoulder areas.
- Update curb ramps at Martin Luther King Trail Middle Road & STH 32
- Upgrade signals at Middle Rd. & STH 32 with use of monotubes
- Replacement of culvert pipes and inlets on the south end of the project.

Real Estate

No real estate is expected to be purchased for this project.

Traffic Impacts During Construction

Construction is currently anticipated to occur during the fall of 2022 or Spring of 2023. Traffic control in the 4-lane area (2-lanes in each direction) will be through the use of single lane closures. In the 2-lane area, traffic control will be through the use of a flagging operation.

- Temporary driveway closures will be needed during milling and paving operations.
- The contractor will be required to give advance notice.
- Most closures will be short term (meaning a few hours).
- Business access will be done in halves, if there is only one access point.
- Side streets will remain open to local traffic only. 7-Mile Road intersection will be staged.
