ARTICLE 1- RECOGNITION CLAUSE

This Agreement is entered into by and between the Village of Caledonia, hereinafter referred to as the "Village", or "Employer", and the Village of Caledonia Highway Department Employees Association, hereinafter referred to as the "Association". The Village recognizes the Association as the sole and exclusive bargaining agent for all regular part-time and regular full-time employees of the Highway Department.

ARTICLE II- WAGES

Effective January 1, 2019, Full Time Employees Across the Board with Caledonia shall receive an increase in total wages applied as a 2.25% increase as follows:

Start (base rate)	20.49/hr.	20.95/hr.
After 1 year	23.55/hr.	24.08/hr.
After 2 years	25.56/hr.	26.14/hr.
After 3 years	28.19/hr.	28.82/hr.

ARTICLE III- DURATION

This agreement shall become effective when signed and shall remain in full force and effect January 1, 2019 through December 31, 2019.
