RESOLUTION 2018-92

RESOLUTION APPROVING AND AUTHORIZING THE USE OF PARK IMPACT FEES FOR PURCHASING AND INSTALLING NEW PARK EQUIPMENT IN GORNEY PARK AND MAPLE PARK.

WHEREAS, a Parks and Open Space Plan for Village Parks was adopted on October 1, 2018 which recommended improvements for all Village parks; and

WHEREAS, the Park Commission approved a budget for playground equipment that follows the Parks and Open Space Plan recommendations for Gorney Park and Maple Park at the September 11, 2018 parks meeting; and

WHEREAS, the Village allows the use of Park Impact fees for new equipment and improvements with Village Board approval.

NOW, THEREFORE, the Village Board of the Village of Caledonia, Racine County, Wisconsin does hereby resolve:

- 1. That the amount of \$60,000, shall be allocated from the Park Impact Fee Fund as set forth:
 - a. Gorney Park a large playground set, installation costs, and incidentals See Exhibit A
 - b. Maple Park a swing set, spring toys, and incidentals See Exhibit A



The Village of Caledonia currently has four available shelters for renting. The most popular shelter is at Crawford Park followed by our two shelters located at Gorney Park and one at Linwood Park.

At Gorney Park one shelter is located on the upper level overlooking our urban pond. There are also two softball fields and several small playground units for the kid's entertainment all with a view from the shelter. This shelter also has one handicap port-a-potty for our guest.

The other shelter is located on the lower level east of the urban pond. There is no playground equipment or activates available when renting. There is a pit house to use instead of a port-apotty.

Basically, Crawford Park shelter with the flushing toilets and two large playgrounds along with tennis, volleyball, and basketball and ball diamonds is rented out more the Gorney Park shelters.

The main reason is all the activities available within view of the shelter. The majority of our renters are hosting birthday parties, graduations or family picnics. There are many young kids and high school teenagers attending and they are all looking for activities to do.

I have asked with several renters why they choose the upper shelter with a single port-a-potty and often more windier then lower shelter that is more protected from the wind. They all had the same answer. There are more activities for the kids meaning the playground equipment plus they can see them from the shelter.



I personally feel the demand for shelter rentals has grown every year but do to attractions within our parks many renters have selected different locations not within the village parks.


I provided this information to the Parks Commission and we all agree that we need to developed more activities around the lower shelter. Our first goal is to add a new playground near the shelter for our younger guest.

Here is our playground unit that the Park Commission has selected along with the location in the park.




The swing set portion would be installed at Maple Park.




Most of the playground units will be built in the gated area by the record storage building. After the unit is assembling it will be lifted down to its location within the playground area with the help of our tractor equipment.

Here is the location for the new playground by lower Gorney Park.

This area is on a slope and excavating along with a retaining wall will need to be done first.



There is one bush for us to relocate.



Next spring we would start with excavating the area and install a retaining wall.
