

RESOLUTION NO. 2018-99

RESOLUTION AUTHORIZING THE VILLAGE OF CALEDONIA TO AWARD A CONTRACT FOR THE DEBACK INDUSTRIAL PARK PHASE 3 IMPROVEMENTS PROJECT REBID

WHEREAS, the Caledonia Utility District has redesigned the sanitary sewer and watermain project area for a 30" Sanitary Sewer, 12" Sanitary Sewer, 8" Sanitary Sewer and a 16" Watermain for serving the DeBack Farms Business Park Phase 3 and 4 Mile Road area; and

WHEREAS, the Village of Caledonia is contractually obligated to provide Sanitary Sewer and Watermain Infrastructure to DeBack Farms Business Park Phase 3 through the Second Amendment to Development Agreement with WisPark LLC. which has been adopted by Resolution 2018-62; and

WHEREAS, the Caledonia Utility District has advertised to receive sealed bids for the DeBack Industrial Park Phase 3 Improvements Project Rebid and 1 sealed bid was received on October 9, 2018; and

WHEREAS, the Caledonia Utility District, held a Public Bid Opening at the Utility District Offices and read the 1 sealed bid; and

WHEREAS, the lowest responsible bidder was Globe Contractors Inc. N50 W23076 Betker Drive Pewaukee, WI 53072, in the amount of \$5,492,315.00; and

WHEREAS, The Utility Director and the Caledonia Utility District's consulting engineer, Foth Infrastructure & Environment LLC., recommended awarding the contract for the DeBack Industrial Park Phase 3 Improvements Project Rebid to the lowest responsible bidder, Globe Contractors Inc. in the amount of \$5,492,315.00; and

WHEREAS, The Caledonia Utility District has recommended to awarding the contract for the DeBack Industrial Park Phase 3 Improvements Project Rebid to the lowest responsible bidder, Globe Contractors Inc. in the amount of \$5,492,315.00 at their October 10, 2018 Regular Business Meeting.

NOW, THEREFORE, BE IT RESOLVED that the contract for the Project be, and hereby is, awarded to the lowest responsible bidder, Globe Contractors Inc. in the amount of \$5,492,315.00, and that the Village President and Village Clerk are authorized to execute any documents necessary to carry out the intent of this Resolution.
