WHEREAS, the Village Board recently approved an amended the Joint Park Agreement between the Village of Caledonia and the Village of Mt. Pleasant for the Caledonia-Mt. Pleasant Memorial Park ("Joint Park") on January 20, 2020. The amended agreement created the Joint Park Transition Commission ("JPTC").


WHEREAS, per the amended agreement, the JPTC is composed of a Trustee of the Village Board of the Village of Caledonia, a Trustee of the Village Board of the Village of Mt. Pleasant, and a citizen from either Caledonia or Mt. Pleasant that is agreed upon by the Village Presidents for both Caledonia and Mt. Pleasant.


WHEREAS, Trustee Thomas Weatherston is a Trustee of the Village Board of the Village of Caledonia, and Joshua Sopczak is a citizen of Caledonia/Mt. Pleasant and has been selected for appointment by the Village Presidents of both Caledonia and Mt. Pleasant.

NOW, THEREFORE, BE IT RESOLVED, that the Trustee Thomas Weatherston and Joshua Sopczak are appointed as Commissioners of the Joint Park Transition Commission for a term of one (1) year commencing on January 27, 2020.
