WHEREAS, the Caledonia Utility District has advertised to receive sealed bids for the Lighthouse Drive Lift Station Upgrade Project and 2 sealed bids were received on February 27, 2020.

WHEREAS, the Caledonia Utility District, held a Public Bid Opening at the Utility District Office and read the 2 sealed bids.

WHEREAS, the lowest responsible bidder was QSP Utility, LLC P.O. Box 310 (29129 Elm Island Drive) Waterford, WI 53185, in the amount of \$191,786.00

WHEREAS, The Utility Director and the Caledonia Utility District's consulting engineer, Foth Infrastructure & Environment LLC., recommended awarding of the contract for the Lighthouse Drive Lift Station Upgrade Project to the lowest responsible bidder, QSP Utility, LLC in the amount of \$191,786.00.

WHEREAS, The Caledonia Utility District has recommended to awarding the contract for the Lighthouse Drive Lift Station Upgrade Project to the lowest responsible bidder, QSP Utility, LLC. in the amount of \$191,786.00 at their March 4, 2020 Meeting.

NOW, THEREFORE, BE IT RESOLVED that the contract for the Project be, and hereby is, awarded to the lowest responsible bidder, QSP Utility, LLC in the amount of \$191,786.00 and that the Village President and Village Clerk are authorized to execute any documents necessary to carry out the intent of this Resolution.

The Lighthouse Drive Lift Station Upgrade has been designed, reviewed and publicly advertised as required. The bid opening for the project was held on February 27th. The Caledonia Utility District received 2 bids for the project. The low bid was from QSP Utility at \$191,786.00. This bid is approximately \$15,700 or 7.5% below the engineers estimate for the work.

Foth Infrastructure and Environment LLC has reviewed the bid and has provided a recommendation for award.
