

**RESOLUTION NO. 2020-21**

**RESOLUTION AUTHORIZING THE VILLAGE OF CALEDONIA TO AWARD A CONTRACT FOR THE TID #4 – FOUR MILE ROAD RECONSTRUCTION PROJECT**

**WHEREAS**, the Village of Caledonia has designed the TID #4 – Four Mile Road Reconstruction Project to improve and upgrade the existing road to a Class A road to serve the area; and

**WHEREAS**, the Village of Caledonia is contractually obligated in the Second Amendment to Development Agreement with WisPark LLC, which has been adopted by Resolution 2018-62, to reconstruct Four Mile Road as a Village Project and as part of the Infrastructure Improvements; and

**WHEREAS**, the Village of Caledonia has advertised to receive sealed bids for the TID #4 – Four Mile Road Reconstruction Project and 1 sealed bid was received on March 10, 2020; and

**WHEREAS**, the Village of Caledonia held a Public Bid Opening at the Village Hall and read the 1 sealed bid; and


**WHEREAS**, the lowest responsible bidder was Reesman’s Excavating & Grading, Inc. 28815 Bushnell Road Burlington, WI 53105, with a base bid (Asphalt with Excavation) in the amount of \$2,115,957.71, an Alternate 1 bid (Asphalt with Geogrid) of \$1,886,084.31, an Alternate 2 bid (Concrete with Excavation) of \$2,409,788.51, and an Alternate 3 bid (Concrete with Geogrid) of \$2,193,547.76.

**WHEREAS**, The Utility Director and the Village’s consulting engineer, Foth Infrastructure & Environment LLC., recommended awarding the contract for the TID #4 – Four Mile Road Reconstruction Project to the lowest responsible bidder, Reesman’s Excavating & Grading, Inc. using Alternate #1 (Asphalt with Geogrid) in the amount of \$1,886,084.31; and

**NOW, THEREFORE, BE IT RESOLVED** that the contract for the Project be, and hereby is, awarded to the lowest responsible bidder, Reesman’s Excavating & Grading, Inc. using Alternate #1 (Asphalt with Geogrid) in the amount of \$1,886,084.31 and that the Village President and Village Clerk are authorized to execute any documents necessary to carry out the intent of this Resolution.
