**RESOLUTION OF THE VILLAGE BOARD OF THE VILLAGE OF CALEDONIA
DISALLOWING THE CLAIM OF YANNA LUGO SANCHEZ, DATED AUGUST 25,
2020 AND FILED WITH THE VILLAGE ON AUGUST 25, 2020, WITH AN
INCIDENT DATE OF AUGUST 10, 2020**

WHEREAS, Yanna Lugo Sanchez presented an Itemized Notice of Claim in the amount of \$4,173.45 pursuant to Section 893.80, Wis. Stat., dated August 25, 2020 and filed with the Village Clerk on August 25, 2020, with an incident date of August 10, 2020 ("Sanchez Claim");

NOW THEREFORE, BE IT RESOLVED that the Village Board of the Village of Caledonia disallows the Sanchez Claim pursuant to Section 893.80, Wis. Stat., dated August 25, 2020 and filed with the Village on August 25, 2020 with an incident date of August 10, 2020, and that the Village Clerk is directed to provide written notice of disallowance as required by Section 893.80(1g), Wis. Stat. and without waiving any and all immunities under the law including but not limited to quasi-legislative immunities under Sec. 893.80(4), Wis. Stat., and any and all defenses, procedural and substantive, of the Village as allowed by law.


RE: NOTICE OF DISALLOWANCE
