There is a need to amend various accounts to reflect actual revenues and expenditures due to over and underfunded accounts. Equipment repairs for the fire department ambulances were discussed. Building maintenance included some garage door replacements and

some of the AC units which were problematic last summer. Professional fees were up in prosecution costs due to the increase of tickets. They discussed the Source of Funds contingency. \$30,000 was lowered to qualify for the budget restraint program. Other accounts were discussed.
