Agenda was taken out of order to take up the Liquor License for C&C Mosquito Inn.

<u>6. Grant 2017-2018 Class B Combination Liquor License – C&C's Mosquito Inn/3208 4 Mile Rd.</u>

Clerk Torkilsen explained to the board that the Legislative and Licensing Committee approved three 2016-2017 licenses back in March. One was a Reserve Class B Combo Liquor License for C&C Mosquito Inn and the two remaining regular Class B Liquor

Licenses were granted to Buddy's Lounge and Ive's Station since they both applied before Mosquito Inn but were approved contingent upon receiving occupancy by the set deadline dates. Buddy's Lounge did meet their deadline and was issued a Class B Combo Liquor License but Ive's Station did not meet their deadline. Mosquito Inn was eligible and applied for the regular license for 2017-2018, leaving Ive's Station with the Reserve License if and when they reapply for 2017-2018.

Motion by Trustee Willing to grant 2017-2018 Class B Combination Regular Liquor License to C&C Mosquito Inn/3208 4 Mile Rd. Seconded by Trustee Benkowski. Motion carried.

Motion by Trustee Benkowski to approve Resolution 2017-57 Establishing the Wage Grade of the Newly Created Court Clerk Position. Seconded by Trustee Willing. Motion carried.

<u>5. To discuss and take action regarding Building Inspector position qualification requirements.</u>

Christensen spoke about the requirement that the Building Inspector become certified in plumbing inspections. Since last meeting, it was decided that more time shall be given to obtain the certification. He now has until April 2018 instead of January 2018. Trustee Wishau asked about the job description. He thought two descriptions exist. One called Building Inspector the other called Building and Plumbing Inspector. No one could confirm that to be correct.
