1. Call the meeting to order.

2. Conduct interviews of the candidates for the Village Board Trustee No. 5 seat

The Board interviewed 4 candidates for the seat. Some Board members felt it is important to appoint someone with some experience especially with the growth spurt bound to happen due to Foxconn.

Dale Stillman, retired from Fiat/Chrysler. His background is in management and is currently the Property Board Chair at Holy Communion. He likes the way the Board works together, the low tax rate and the ruralness of Caledonia. He is a regular voter and tries to keep up on topics. He may think about running in April if not selected for the appointment. He is in favor of TIDs, if done for the right reasons.

Thomas Witek Jr., currently works for Great Northern Corp and is Board Treasurer for Koss Family Foundation. Growth and safety are important issues to him. He likes the rural character of Caledonia. He may think about running in April if not selected for the appointment. He is in favor of TIDs if done for the right reasons. He is not a Spring Election voter.

Fran Martin, retired Attorney. She loves Caledonia and believes her background and current involvement with the Village, such as chair of the CDA, makes her a knowledgeable and beneficial candidate. She was noncommittal about if she would run for a seat if not appointed.

Dave Prott, Highway/Park Superintendent of Public Works and Development Services. Dave was a current Village Board member. His goal is to secure development along I-94 to cover the TID. He talked about the need to work through the process of comparing the Land Use Plan against the current 2035 Plan for incorporation into the 2050 plan. He would not want to run against an incumbent in the Spring Election if not appointed.
