5 - Citizens Reports/General comments from the audience

No other comments were made other than those addressing agenda item 6A.

6 - Communications and Announcements

Theresie Bode, 704 Waters Edge Rd, said nothing has been done to re-secure the building such as the window that is wide open with a big board propped up against it that is obviously used to get in and out of the building. She felt that the Board is not seeing this as top priority. She also felt it should be placed on the agenda as a discussion instead of a report. She felt that the Board is implying this to be a conflict and explained that the people are looking to the Board for a solution and they are willing to help out in any way possible. References were made to the Ordinances, specifically the declaration of public nuisance and how if after 10 days, anything labeled as a public nuisance is not taken care of, it is torn down.

Ron Schulgit, 720 Waters Edger Rd., felt as a physician there is a medical issue there. He referred to the asbestos and mold in the building and his concern for the health of the Officers that enter the building, especially if they are smokers. He brought up the possibility of law suits if someone gets hurt inside the building.

A. Update on the Western Publishing Building

Christensen explained that first and foremost there is no conflict. He will make time to get over there personally. He said the week of Labor Day there will be an inspection done. At that time they will find out which Ordinance it violates. They discussed that according to the paper, there was a committee formed in 2015 for the building. Christensen explained that no one recalls any type of committee ever being formed.

Bode suggested that instead of wasting time with a new inspection they should use the old inspection. Christensen explained that an new inspection needs to happen. Bode stated that that according to building code where alteration are concerned, they are disallowed to a building in disarray and that is structurally unsound.

A gentleman spoke about a developer who said that the building is obsolete and nothing can be done with it.

Ron Schulgit reiterated the importance of the health and safety factor. He stated that anyone entering the building doing the inspections and reviews should be wearing a mask.

Scott Dizack, 700 Waters Edge Rd, said the building needs to come down. He felt everyone should sit down and figure out a way to accomplish this including Unified School District. Maybe form a committee. Christensen said that he has had conversation with Dave Hazen from Unified. They recognize the problem and it will be discussed.

Roseanne Worrell, 700 Waters Edge Rd, spoke about the loud air conditioning.

President Bradley stated that there are a lot of layers in taking care of this. Legal is working on it, the inspection is scheduled and it will be boarded up. The Building, Health and Fire Departments will be the first to do inspections. This will be a standing agenda item until this is resolved.
