#### 8F - Resolution 2018-08 - Resolution Amending The 2017 Capital Projects Budget

Finance Manager Larry Borchert explained that this Resolution accomplishes 3 things. First it closes out the new village hall construction fund, which required an additional \$25,639.00 to finish the construction with a 3.5 million dollar budget. Second, this closes out the Capital Projects fund for 2017. Lastly it restricts \$224,000 in the Capital Projects fund, which the Village received from the sale of the East Side Community Center.

The new village hall construction had a budget of 3.5 million, and the funding received on a bond sale was 3.46 million, Construction costs amounted to \$3,499,982.10, which required a transfer of \$25,639 from the Capital projects fund over to the new village hall fund, and then were able to close out the new village hall fund. The Capital Projects fund of 2017 had a fund balance of \$17,587 so there is still adequate money in the Capital Projects fund to close out. We restricted \$520,000 approximately 2 years ago from the sale of the Sienna Center for the 4 ½ Mile project, as well as the \$224,000 from the sale of East Side.

Finance Committee recommended approval. Trustee Wishau congratulated Borchert on a job well done.

Bonding proceeds of \$3,461,728.81, totaled less than the \$3,500,000 construction budget (3,600,000 including contingency) the village hall construction totaled \$3,499,982.10.

Motion by Trustee Trentadue to adopt Resolution 2018-08 Amending The 2017 Capital Projects Budget. Seconded by Trustee Wanggaard.

Utility Commission President Howard Stacey explained the reasons the Utility Commission denied the request such as this property is not in the district. The property owner is only interested in the water service but it is Village policy that both water and sanitary sewer be installed. And owner is not interested in sanitary sewer and the CDA is in the process of reviewing the 2035 Comprehensive Plan and if the property of reclassified, the owner can make a new request.

Trustee Wishau stated that although he didn't want to put words in the applicant's mouth, after discussing the cost the applicant would incur, he felt it would be more advantageous to move his well. Trustee Wanggaard questioned why he didn't withdraw his request knowing it was cost prohibitive.

Motion by Trustee Willing to deny the water service request at 8538 Hwy 38. Seconded by Trustee Wishau. Motion carried, 4/1.

#### 10 - Report from Village Administrator

Administrator Christensen thanked the Board for their continued confidence, and allowing him to continue to serve the Village of Caledonia.
