<u>8A - Resolution 2018-10 – Resolution Of The Village Board Of The Village Of</u> <u>Caledonia Approving The Predevelopment Agreement For The Audubon</u> <u>Arboretum Subdivision For Property Located At The Southwest Corner Of 5 ½</u> <u>Mile Road And Charles Street</u>

Lazcano explained that the Resolution is for the allowance of engineering fees, review fees, legal fees, and miscellaneous fees to be collected during the development process for the Audubon Arboretum Subdivision.

Motion by Trustee Benkowski to adopt Resolution 2018-10 Approving The Predevelopment Agreement For The Audubon Arboretum Subdivision For Property Located At The Southwest Corner Of 5 ¹/₂ Mile Road And Charles Street. Seconded by Trustee Prott. Motion carried unanimously.

8B - Resolution 2018-11 – Resolution Designating The Village Of Caledonia Finance Department As The Financial And Payroll Accountants For The Caledonia Sewer And Water Utilities

Christensen stated the Wisconsin Unemployment Office has requested a Resolution that names the Village of Caledonia Finance Department as the financial and payroll accountants for the Sewer and Water utilities.

Motion by Trustee Wanggaard to adopt Resolution 2018-11 Designating The Village Of Caledonia Finance Department As The Financial And Payroll Accountants For The Caledonia Sewer And Water Utilities. Seconded by Trustee Trentadue. Motion carried unanimously.

<u>8C - Resolution 2018-12 – Resolution Authorizing The Adoption Of An Updated</u> Fair Labor Standards Act (FLSA) Policy For The Village Of Caledonia

Christensen gave detail on how this Resolution formally states our adoption of the Fair Labor Standards Act (FLSA) policies regarding overtime and hours worked. It also provides an exemption for the Highway Department employees who are working snow removal operations and Utility Department employees who are working between November 1 and April 30. They will receive time and a half or compensation time for hours worked over 8 per day, so that they do not have to have a full 40 hour week before they earn time and half premium overtime. This has been through Personnel Committee and they recommended approval.

Motion by Trustee Benkowski to adopt Resolution 2018-12 Authorizing The Adoption Of An Updated Fair Labor Standards Act (FLSA) Policy For The Village Of Caledonia. Seconded by Trustee Trentadue. Motion carried unanimously.

8D - Resolution 2018-13 – Resolution Of The Village Board For The Village Of Caledonia Approving The Audubon Arboretum Subdivision Concept Plan For Plat Revision – 5 ¹/₂ And Charles St., Parcel Id's 51-104-04-23-17-084-000, 51-104-04-23-17-085-000 & 51-104-04-23-17-086-005; Audubon Park Racine, LLC, Owner

Lazcano described how the subdivision was originally approved in 2007, and is now being brought to fruition. There are a few revisions from the original concept plan, such as lot sizes, number of lots, and changes to the way some of the way the roads are set up. These changes will create less maintenance for the Village in the future. There was concern regarding a road change, specifically the cul-de-sac link but they have since spoken to the Fire Department and received an okay (and will be sending an email saying so). Plan Commission has reviewed and recommended approval.

Bunkelman explained the proposal. This was reviewed by the Plan Commission, and they recommended approval.

Stats. Seconded by Trustee Prott. Motion carried unanimously.

<u>8F - Resolution 2018-15 – A Resolution Of The Village Board Of The Village Of</u> <u>Caledonia Authorizing The Spending Of Certain Park Impact Fees</u>

Christensen said that the Park's Commission has been working on an updated needs assessment and the assessment is scheduled to be completed in a few months. They are ready to move forward with a certain number of projects, but they need engineering and design services to prepare a site plan. This Resolution proposes to use \$25,000 of impact fees towards that site plan.

Scott Warner was present and explained how this request is for the study of 8 ½ acres of Crawford Park adjacent to Caledonia Village Hall.

Motion by Trustee Benkowski to adopt Resolution 2018-15 Authorizing The Spending Of Certain Park Impact Fees. Seconded by Trustee Willing. Motion carried unanimously.

<u>8G - Resolution 2018-16 – Resolution Amending Various Accounts In The 2017</u> <u>Village Of Caledonia Budget To Reflect Actual Revenue And Expenses More</u> <u>Accurately</u>

This is a standard process done annually to amend the over spent accounts and under spent accounts. Borchert explained the amendments. There is a net surplus of \$291,020 for 2017. The \$291,020 surplus came from revenues being \$347,000 over what we budgeted, and our expenditures being \$56,000 over budget. The General Fund balance had a transfer of \$372,000 to the 2017 Capital Projects Fund which should help fund the construction of the Highway Garage Project. Borchert explained the expenditures; the amounts from expenditures accounts that were under budget were used to fund accounts that were over budget. They also took from 3 revenue accounts that were over budget to fund additional accounts. The investment interest went well in 2017, every month Borchert strategically left just enough to pay the bills in the Tri City bank account and left the rest to collect interest. There is a fund balance of \$4,678,000 and there has been a surplus every year for the past couple of years.

Trustee Prott asked if there was a threshold that needed to be met in order to improve our credit rating? Borchert explained that a fund balance policy was adopted in 2017, and the lower limit that yields a decent credit rating is 20% of your general fund budget of the year and felt that's efficient to carry over in the event of a down turn.

Motion by Trustee Benkowski to adopt Resolution 2018-16 Amending Various Accounts In The 2017 Village Of Caledonia Budget To Reflect Actual Revenue And Expenses More Accurately. Seconded by Trustee Trentadue.

<u>8H - Resolution 2018-17 – Resolution Of The Village Board Of The Village Of</u> <u>Caledonia Authorizing The Application For And Use Of Credit Card On Behalf Of</u> <u>The Village</u>

Christensen stated this it to authorize the new credit card program and identifies the vendor. There is a substantial return in the program, and is a benefit to the Village. The program will be reviewed annually in order to secure the best deal for the Village. Finance Committee reviewed and recommended approval.

Motion by Trustee Wanggaard to adopt Resolution 2018-17 Authorizing The Application For And Use Of Credit Card On Behalf Of The Village. Seconded by Trustee Willing. Motion carried unanimously.

8I - Resolution 2018-18 – Resolution Of The Village Board Of The Village Of Caledonia Accepting Work For The DeBack Industrial Park Intersection And Bypass Lanes

Bunkelman explained this is part of the Development Agreement with DeBack Farms. The Village was required to perform the projects within the existing right-of-way, specifically the East Frontage Road right-of-way. The project was performed by A.W. Oakes, and they have accomplished all the work required. There has been an inspection of the work performed and it has been found to conform to Village Standards. Bunkelman recommended approval.

Motion by Trustee Wanggaard to adopt Resolution 2018-18 Accepting Work For The DeBack Industrial Park Intersection And Bypass Lanes. Seconded by Trustee Trentadue. Motion carried unanimously.

9 – New Business

<u>9A – A Permit To Perform Utility Work Within Road Right Of Way For The</u> <u>Caledonia Utility District's STH 32 Utility Improvements Advanced Utility Work</u> <u>Project</u>

Bunkelman stated that the Utility District is seeking to re-lay approximately 80 feet of sanitary sewer, and about 740 feet of water main along south side of 6 Mile Road rightof-way, east of Douglas Avenue. This work is necessary for the reconstruction of Highway 32 and 6 Mile Road. East of Highway 32 is being constructed by the DOT later this year. The Utility District is publically advertising this project and will hold a bid opening. The project also includes areas along Douglas Avenue for sewer and water adjustments or improvements in anticipation of the Highway 32 project being performed by the DOT. The Village requires a Road Opening Permit for the right-of-way on 6 Mile Road which the Village has jurisdiction. The Utility District has applied for and received a Road Opening Permit from the DOT in regards to the Highway 32 right-of-way.

Motion by Trustee Wanggaard to authorize A Permit To Perform Utility Work Within Road Right Of Way For The Caledonia Utility District's STH 32 Utility Improvements Advanced Utility Work Project subject to conditions outlined in memo dated Wednesday, January 31, 2018 from Public Works Director. Seconded by Trustee Benkowski

<u>10 - Report from Village Administrator</u>

Christensen is anticipating a decision on funding for the Hoods Creek bridge project within the next couple of months.
