Christensen explained some of the revisions to the draft since last meeting due to receiving some final numbers. Hwy Aids where higher than expected, personal property aid was calculated. Worker's Comp Mod Rate increased significantly while overall liability coverage came in less. Changes recommended were to eliminate use of fund

balance, reduce General Fund property tax levy, increase Worker's comp, create a Self-insured Retention line item, adjust the Highway wages, and add Auto Chest Compression Systems to the Fire Dept. capital budget and increase to the contingency line item.

Motion by Trustee Benkowski to approve the draft 2019 Budget. Seconded by Trustee Martin. Motion carried unanimously.
