5. Discussion and possible decisions regarding Joint Park Operations and Management, all 2019 Events at the Caledonia/Mount Pleasant Joint Park, including the 2019 Kraut Fest, Food Truck Festival, and Movies in the Park.

Brian Sweeney was present on behalf of the Kraut Fest Committee. There was discussion on budgets and coordination regarding the possibility of the Fest coming to fruition in 2019. Sweeney felt given the circumstance and timing that the Committee does not feel it would be possible to hold the Kraut Fest this year. An official answer would need to be provided to the Village by the Committee.

Ken and Molly Michel were present on behalf of the Food Truck Festival, (9/6 & 9/7) they do have committed vendors, and have been working with the Villages to ensure this is set up correctly. They provided an at a glance view of the events being hosted exclusively at the Beer Garden that highlighted dates, times and maps that presented how the events would be laid out.

"Movies in the Park" was not discussed as a 2019 event, but the Beer Garden does host their own movie night that is not affiliated with the event previously hosted by the Parks.

There was discussion regarding the Commission needing to eventually appoint a liaison to the Beer Garden as a point of contact.
