Trustee Benkowski requested the portion below be added to the minutes as dialogue:

Trustee Benkowski:

"For the minutes for tonight, I would like it added on as dialogue. I guess a concern that was raised to me that it has been suggested that I'm not properly prepared through the minutes or the packet as being an active, engaged and forthright member of the Village Board. It's my understanding that these conversations came to me from Tom Christensen; it's being exchanged as a whisper campaign against me and I would just calmly say that today I'm fully prepared, as I have been since I've been a member of this Board and I'm fully engaged and I care about representing the citizenry of this community and I'd like to stop this, requench this slander and negative aspersion against my character. But, I guess more to the point, if this is coming because I had a position that I fought Tom at the second aspect of his package for compensation after we gave him the salary adjustment, that's an unfortunate way to proceed. So please make that on the minutes and I take great issue with that if he's doing the slander against me, he can do whatever he wants to in finds of his life out of the Village, but if this is occurring in the Village Hall that is inappropriate. Thank you."

Trustee Martin:

"I guess I would like to address that briefly in this respect, last year when I ran, an anonymous post card was sent out saying don't vote for Fran Martin, etc. on the eve of the election. It's unfortunate if Caledonia elections have slipped down from the high standards that I think the Village as a whole has. I don't, I know that Mr. Weatherston is Jay's opponent; I do not think this is emanating from Mr. Weatherston, who's here. I do think that it is a very unfortunate, I have

heard that same rumor, whisper, whatever it is and it attributed to Mr. Christensen. I did not hear him say that, but I did hear that."

5 - Citizens Reports/General comments from the audience

Ray Lentz, 7124 Hwy 38, spoke about previously begging leaders to get involved in correcting a multitude of local injustices but felt his request was met with disinterest. He reminded the Board that they are servants to their constituents and reprimanded their bad attitudes. He thought they should do more with their positions in power than help friends and collect their supplemental paychecks. He stated that instead of investigating the almost unbelievable accusations, they've chosen to just not believe them and turn a blind eye. He reminded everyone of his willingness to take a lie detector test, but felt the leaders were too deeply committed to overserving a select few opposed to discovering his truth. In his opinion until they start to work for all their constituents, they did not deserve to draw wages, especially the raises given as late. In his 61 presentations, he feels no improvement has been made. He welcomed the opportunity to help them in hopes to provide Caledonia with quality leadership.

6A - Wellness Initiatives Presentation from Horton

Alex Beaudry, a representative of The Horton Group was present and spoke about Humana's wellness program. Participation in the program, called Go 365 gives a percentage of reduction of the renewal plan. Some examples of getting people to participate is to offer some sort of incentives such as offering people a health insurance percentage then they can buy down to a lower premium. It can also be tied to a health reimbursement account. This will go to the Personnel Committee for review.

Tom Lazcano explained some of the AP Checks that were questioned:

- The Parks and Open Space charge was for the Parks and Open Space Plan that was completed by SWRPC, the money was budgeted in the 2016 budget and it took until now for it to be finished because of the Public Hearings and Ordinance process.
- The salt service is for the Village Hall parking lot. The DPW does not service Village Hall because it requires smaller trucks and their plows would damage the parking lot.
- Although our contract with Racine County for zoning has expired, we are using their services until the new Planning Director is hired. The zoning services are being paid on a per hour basis.
