8F - Resolution 2019-44 - Resolution Of The Village Board Of The Village Of Caledonia For Outdoor Recreation Grants And Aids For The Village Of Caledonia, Racine County, WI

This is a requirement in order to apply for any grants. They will check on how many years the Resolution is good for.

Motion by Trustee Benkowski to adopt Resolution 2019-44. Seconded by Trustee Wanggaard. Motion carried unanimously.

8G - Resolution 2019-45 – Resolution Authorizing The Snow And Ice Control Policy

This is a policy regarding current practices for snow and ice removal as well as adding a 16 hours maximum worked with a mandatory 8 hour rest period between shifts. There may be additional people needed to fill in for snow removal. Chief Reilly spoke about the loss of reaction time after someone has been awake for 17 hours. He felt it is not safe to keep people working after 16 hours. There should be a plan in place for snow removal after 16 hrs.

There are currently three utility district employees to fill in when needed. They discussed if the Village is competitive with part time wages. Trustee Prott stated that municipalities are exempt from the CDL rules. Trustee Prott did not understand the numbers or the hours in the policy and was not in favor of it.

Motion by Trustee Benkowski to adopt Resolution 2019-45. Seconded by Trustee. Motion carried unanimously.
