# **7B(1) - Approval of 2019-2020 Operator's Licenses (Bartenders)**

Motion by Trustee Prott to approve 2019-2020 Operator's License as presented. Seconded by Trustee Wanggaard. Motion carried unanimously.

## 7B(2) - Bartender License Appeal – Kesley Dvorak Phillips

Applicant was not present.

Trustee Prott explained that this application was brought to the Legislative/Licensing Committee for an interview with the applicant. After review, the Committee recommended denial of the application based upon multiple alcohol related incidents on the applicant's background check.

Trustee Wanggaard stated that although her probation officer was ok with her bartending, he was not. He felt given her poor history with alcohol, it would not be in the best interest for her to work in a bar serving alcohol. Trustee Martin agreed, and felt although she is very much in favor of giving someone a second chance, the frequency of these transgressions and the fact that they relate to drugs and alcohol, it is not in the best interest of the Village nor the applicant to put someone with these convictions in charge of serving alcohol. Trustee Martin was also concerned with the recentness of the convictions.

Trustee Wanggaard moved to deny the Application for License to Serve Fermented Malt Beverages and Intoxicating Liquors due to a history of convictions that demonstrate a lack of good judgement as they relate to alcohol and the restriction that stated no alcohol. Seconded by Trustee Prott. Motion carried unanimously.

8A - Charter Ordinance 2019-001 - 1<sup>st</sup> and 2<sup>nd</sup> Reading and Possible Adoption - A

Trustee Martin originally voted against suspending the rules since she wanted to discuss it further. The second

reason was due to the timeframe of 60 days before it can be adopted. Trustee Martin changed her mind and decided to move forward with the 1<sup>st</sup> and 2<sup>nd</sup> reading.

The President of the Commission was present and stated that he would be fine either way and would still serve. President Dobbs stated that he brought it up because to be fair, he felt either all the volunteers should get paid or none of them.
