Ray Lentz, 7124 Hwy 38, criticized the Board for putting conditions on his newly rezoned parcel. He provided some examples that he considered ridiculous, and thought every move he made would need to be approved by the Board. He stated that the Board is a disgrace to the human race.

8A - Ordinance 2019-14 – 2nd Reading and Possible Adoption – An Ordinance Adopting An Amendment To The Multi-Jurisdictional Comprehensive Plan For Racine County: 2035 As It Pertains To The Village Of Caledonia Under Section 13-2-1 Of The Village's Code Of Ordinances By Creating Section 13-2-2(M) Adding An Amendment To The Village's Comprehensive Plan And Affecting Part Of The NE 1/4 Of Sec. 19, T4N, R23E, Village Of Caledonia; Located On A Vacant Lot North Of 5913 Douglas Avenue And Containing 0.68-Acres, More Or Less; From High Density Residential To Commercial; WL Investments LLC, Owner

Trustee Martin wanted to clarify that she opposed the first and second readings at the November 4<sup>th</sup> meeting because she wanted to ensure there was sufficient notice. She was concerned that there is not a plan for Douglas Avenue, and thought the goal is to improve the corridor. She was against piecemealing small rezones as it formed the entrance to Caledonia but is not opposed to approving this.

Trustee Wishau questioned the land use map and clarified the parcel was not a flag lot but a parallelogram lot.

## 8G - Ordinance 2019-20 – 1st Reading and 2nd Reading and Possible Adoption – An Ordinance To Amend In Part And To Create In Part Title 12, Chapter 4 Of The Village Of Caledonia Code Of Ordinances As It Pertains To The Village-Owned Cemetery Located In The Village Of Caledonia

Motion by Trustee Weatherston to suspend the rules to conduct the 1st and 2nd reading and adoption of Ordinance 2019-20. Seconded by Trustee Wanggaard. Motion carried unanimously.

Motion by Trustee Weatherston suspend the rules to read Ordinance 2019-20 by title only. Seconded by Trustee Martin. Motion carried unanimously.

Motion by Trustee Weatherston to adopt Ordinance 2019-20. Seconded by Trustee Wanggaard. Motion carried unanimously.

### <u>8H - Resolution 2019-105 – Resolution Of The Village Board Of The Village Of Caledonia</u> <u>Establishing The Compensation For The Village Municipal Judge</u>

Motion by Trustee Prott to layover Resolution 2019-105. Seconded by Trustee Martin. Motion carried unanimously.

8I - Resolution 2019-106 – Resolution Imposing A Special Charge On The 2019 Tax Roll Representing The Annual Storm Water Management Fee Against Property In The Village Of Caledonia Utility District And Establishing The Storm Water Management Rate For Each Equivalent Residential Unit In Accordance With Sections 9-2-12(G) And (H) Of The Village Of Caledonia Code Of Ordinances For The Time Period Of 12/1/2019 To 11/30/2020

Anthony Bunkelman explained that the Storm Water Utility District ERU (Equivalent Residential Unit) was adopted in 2013. Each year they review the ERU's in the Village. Last year there was a total of 15,324 ERU's and an overall budget of \$998,600. After this year's review there are 15,455 ERU's and an overall budget of \$1,007,265. The ERU rate of \$65.25 will remain the same as last years. Bunkelman further reviewed the different classes for ERU's. He explained the credit policy that allows anyone to challenge the ERU charge. He recommended approval.

Motion by Trustee Weatherston to adopt Resolution 2019-106. Seconded by Trustee Stillman. Motion carried unanimously.

### 8J - Resolution 2019-107 - Resolution Authorizing The Village Of Caledonia To Execute A Stormwater Easement Agreement With Tom4D Investments LLC - Midwest Forms & Supply LLC - 3910 Quick Drive

Bunkelman explained that in 2018 Midwest Forms & Supply came the Utility District with a storm water plan and a site grading plan. It was approved on the contingency of an easement being granted over a storm water facility that was going to be installed by the developer on the site. The owner has signed off and submitted the agreement. He recommended approval so this document can be executed and recorded.

Motion by Trustee Prott to adopt Resolution 2019-107. Seconded by Trustee Martin. Motion carried unanimously.

# 8K - Resolution 2019-108 – Resolution Of The Village Board Of The Village Of Caledonia Revising Fees For The Caledonia Memorial Park Cemetery Under Sec. 12-4-7 Of The Village's Code Of Ordinances And Establishing And Approving The Caledonia Memorial Park Operating Policies And Procedures Under Sec 12-4-3 Of The Village's Code Of Ordinances

Attorney Helsel explained that this runs in tandem with the Ordinance that was just adopted. This resolution establishes and raises fees of the cemetery. The last time the fees were adjusted were in 2011, and brings up the fees to be competitive with surrounding area cemeteries. These may be adjusted again when a Cemetery Director is hired. This newly formed operating policies and procedures are more comprehensive and assist in governing the cemetery.

Trustee Martin questioned if the Cemetery Director would be an appointed position. Attorney Helsel confirmed that this position would both be appointed and directed by the Board.

Trustee Stillman found a discrepancy in the Ordinance regarding the foundation height and depth.

Motion by Trustee Wanggaard to adopt Resolution 2019-108 with corrections by Trustee Stillman. Seconded by Trustee Weatherston. Motion carried unanimously.

### 8L - Resolution 2019-109 - Resolution Approving And Authorizing The Adoption Of The 2020 Budget For The Village Of Caledonia, Authorizing, Fees, Capital Projects, And Setting Various Tax Levies

Christensen explained the exhibit and amendments that were made. The changes included: the removal of items from TID 4 budget (no change to tax levy), and increase in the 2019 recycling fee to \$60.00, and the addition of the Hoods Creek Bridge Project to the Capital Budget no change to tax levy). He recommended approval.

Motion by Trustee Prott to adopt Resolution 2019-109 with the amendments presented in Exhibit A. Seconded by Trustee Stillman.

### 8M - Resolution 2019-110 - Resolution Approving A Professional Services Agreement With Carlson Dettmann Consulting, LLC

Christensen explained that Carlson Dettmann Consulting, LLC, is a consulting firm that the Village would like to assist with the preparation of the arbitration documents necessary for the Fire Department arbitration. It is tentatively scheduled for mid-January. It is more economical to use Carlson Dettmann for these services opposed to using the attorney. There is also a "not to exceed \$5,000" for funding of this arbitration.

Trustee Martin disagreed with this approach. There is an upcoming meeting with surrounding municipalities to discuss consolidation of fire services, and she thought it would be best to wait and see the outcome of those discussions. The Board disagreed, and thought the consolidation of those services would take time, and this arbitration would take place sooner.

Motion by Trustee Stillman to adopt Resolution 2019-110. Seconded by Trustee Weatherston. Motion carried, 6/1.
