5 - Citizens Reports/General comments from the audience

Nancy Washburn gave an Auburn Hills update regarding the improvements which were done. She also held a meeting with the residents on November 7th at which time a clear path and direction was set for the Auburn Hills HOA.

Gordon Anderson from Mona Park Drive was present in opposition to the thought of a kayak and canoe launch on Mona Park Drive. He also had concerns with a resident on Mona Park using his personal residence as an Airbnb. Trustee Weatherston explained there is nothing in the works by the Village to do a launch on Mona Park and it would have to go through the proper channels if there was. He invited people to attend the Park and Rec Commission meetings.

Tom Furuglyass was present in opposition to the launch as well. He spoke of Caledonia taking down his fence 6 years ago.

Many people were present in opposition to the rezoning project at the intersection of Hwy 38 and 31.

Ray Lentz, 7124 Hwy 38, criticized the Fire Dept., Police Dept., Village Administrator, Village Planner, Village Highway, etc. He accused everyone of performing special favors.

Clerk read the title.

Motion by Trustee Wanggaard to adopt Ordinance 2019-19. Seconded by Trustee Martin. Motion carried unanimously.

Motion by Trustee Wanggaard to adopt Ordinance 2019-16. Seconded by Trustee Prott. Motion carried unanimously.

8B - Ordinance 2019-17 - 1st and 2nd Reading and Possible Adoption - An Ordinance To Amend Section 2-3-12(A) Of The Code Of Ordinances For The Village Of Caledonia Pertaining To Ordinance Adoption Procedures

Motion by Trustee Wanggaard to suspend the rules and take up both 1st and 2nd reading of Ordinance 2019-17. Seconded by Trustee Stillman. Motion carried unanimously

Motion by Trustee Weatherston to suspend the rules and read by title only. Seconded by Trustee Stillman. Motion carried unanimously.

Trustee Martin was opposed to this because she said it does not give proper notice. She stated that technically the Board could pass something in one meeting. Attorney Ekes explained that this is an old fashion rule due to modern technology. It is an unusual rule. With respect to bringing Ordinance to the Board, it usually goes through a committee first or commission where a public hearing is usually required. No other community uses this procedure. The Board does have authority to lay an item over if more time is needed. Trustee Wanggaard discussed the committee level where discussion is held and many other Board members attend. Trustee Wishau agreed with Trustee Martin and felt not all Board members can attend the Committee meetings.

Clerk read the title.

Trustee Martin reiterated her opposition to the Ordinance.

Motion by Trustee Weatherston to adopt Ordinance 2019-17. Seconded by Trustee Stillman. Motion carried, 5/2.

8C - Ordinance 2019-18 - 2nd Reading and Possible Adoption - An Ordinance To Create Chapter 7 Of Title 15 Of The Code Of Ordinances For The Village Of Caledonia Pertaining To Property Exterior Maintenance Code

Motion by Trustee Wanggaard to suspend the rules and read by title only. Seconded by Trustee Stillman. Motion carried unanimously.

Clerk read the title.

Motion by Trustee Stillman to adopt Ordinance 2019-18. Seconded by Trustee Weatherston. Motion carried unanimously.

Wagner explained that this strengthens the code to encourage people to clean up their property. Specifically blighted properties. It will help reduce unsafe and unsanitary properties.

8E - Ordinance 2019-20 – 1st and 2nd Reading and Possible Adoption – An Ordinance To Amend In Part And To Create In Part Title 12, Chapter 4 Of The Village Of Caledonia Code Of Ordinances As It Pertains To The Village-Owned Cemetery Located In The Village Of Caledonia

Motion by Trustee Weatherston to lay over Ordinance 2019-20. Seconded by Trustee Stillman. Motion carried unanimously.

Motion by Trustee Weatherston to suspend the rules and take up both 1st and 2nd reading of Ordinance 2019-21. Seconded by Trustee Stillman. Trustee Martin, nay. Motion fails for lack of a unanimous vote.

President Dobbs wanted to open discussion due to the amount of people in attendance. Motion by Trustee Weatherston to suspend the rules and read by title only. Seconded by Trustee Wanggaard. Motion carried unanimously.

Clerk read the title.

Wagner explained that Northwestern III LLC has applied for a rezoning to the land use map at this property for a potential gas station and quick service restaurant. Before commercial uses are approved, many rules are in place to help mitigate things such as lighting and landscaping which can help buffer between commercial and residential properties. Trustee Martin questioned reducing the property amount to be rezoned. Trustee Stillman asked if it could be rezoned B2 instead to be more restrictive. A map of the potential development was viewed and discussed. Ekes explained that the Comp Plan governs but the Board can govern the intensity.
