Ray Lentz, 7124 Hwy 38, criticized a Board member. He thinks he is being treated like a toilet.

A comment was made that Main Street has a much nicer view than Douglas Ave. He likes to ride his bicycle and feels Caledonia is lacking in bicycle trails.

Many people were present in opposition of the rezoning on Hwy 31 and Hwy 38. Two women from Patzke Road expressed their disapproval. Some of the concerns expressed included:

Saving the wildlife, dangerous intersection and air quality.

Marc Silverman questioned what constitutes abutting properties. He also questioned the 2 minute timeframe for public comments. He said the code says 5 minutes with a 3 minute rebuttal.

Ekes stated that the ordinance was amended and the rebuttal was eliminated. The 5 minutes is for a public hearing, not public comments. Generally, abutting means properties that touch but can sometimes include across the street depending upon where the proposed land is located.
