There are three focal options for possible management which include: the operations would be transitioned to Racine County, Village of Caledonia would handle operations solely, or a partnership with the Village of Mt. Pleasant would continue. President Dobbs was interested in the Commission's opinion and expressed wanting to meet with President Degroot to discuss options for the future of park management to be brought back to their respective Boards. Attorney Helsel stated he would make a model of the three potential options discussed and recommendations could be made to the respective Village bodies that would then be moved forward to the transition commission.

## 6. RASA Park Use Agreement Update

Attorney Helsel explained that a completed draft was sent to RASA and RASA is still reviewing it. The only comments received back so far was regarding RASA's exclusive use of the parking lot; there were some conflicts with the Beer Garden regarding parking and exclusive rights on the weekend would be problematic. Helsel stated that he spoke with RASA regarding a tentative meeting happening next week to finalize the agreement and hoped it could be signed by then.
