### 1. Call the meeting to order

President Dobbs called the meeting to order at 4:49 p.m., at the Village Hall.

#### 2. Alex Beaudry from Horton on 2021 Health Insurance.

Beaudry presented to the Board in July and at that time stated he would come back in September with numbers for the 2021 renewal. The medical renewal is running high at 30.19% because of some high-rate claims. Horton is not accepting the rate change as is and will be exploring other options and creative solutions. He had no new data or numbers to present outside of the medical renewal and is hoping to have more information by October 12<sup>th</sup> – 19<sup>th</sup>. There was discussion regarding the rate and the possibility of exploring different types of plan changes. Last year the dental insurance was switched from Humana to Metlife and Metlife has a rate increase of 7%. There have been some issues with Metlife, and Horton will also be shopping for some newer dental and vision options.

3. The Village Board will take up a motion to go into CLOSED SESSION, pursuant to s. 19.85(1)(e), Wis. Stat., deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session: specifically to discuss a possible development in Tax Incremental District No. 5.
