6 - Communications and Announcements

6A - Presentation by RUSD regarding April Referendum

Shannon Gordon presented. RUSD spent a year working with facilities expect and demographic analysts to assess conditions of school buildings, access educational adequacy of buildings and analyze community demographics now and into the future. The average building is 78.5 years old. In some cases, costs are higher to maintain than to build new. A lot of the details to back this up is on the RUSD website along with the master plan. Construction of new schools include K-8 in Sturtevant, expand Starbuck to a K-8 International Baccalaureate campus, New Red Apple Elementary STEAM school in City of Racine, create smaller middle schools, create second early learning center at West Ridge, increase STEM\STEAM across District to improve math and science skills, expand successful programs, consolidate and expand based on changing demographics, modernize, enhance safety and security, increase modern technology and create schools that are ADA compliant. The Board has acted on maintaining a stable mill rate. Things

put in place to hold RUSD accountable include key performance indicators for superintendent, tax control policy, stakeholder engagement policy, ongoing reports to Board of Education and public, implement progress, demographic changes, long-range plan changes based on new data, continuous authorization requirement for fiscal decisions and program management firm support. The referendum will be placed on the April 7th ballot.

Further discussion was held with questions and comments from the Board. (answers below are generalized and not verbatim) RUSD can't promise stable tax rates for future school board members. Why isn't RUSD asking for funding in phases? What is the contingency plan? Answer: there is a need now. Will this help raise graduation rates? Answer: no, it will not, but it is a way to try to move forward and provide safety and the best learning environment. How will this change the reputation of RUSD? Answer: They are starting to see kids coming back to Unified due to the academies. Why are heating upgrades included in brand new schools in phase one. Answer: commissioning work needs to be done to see that the architect's signers did their jobs and the schools are energy efficient. A need for tracking the various referendums. Answer: information like that is on the website. What is RUSD doing about disruptive kids? Answer: more and more kids are coming with health concerns, violence at the home, etc. there are not enough teachers to support the various needs but RUSD will always keep trying to help those students. They are working on having special areas, etc., while working on training teachers and giving them the tools they need to support student success. This is the same information and promises that some of the Board members heard 13 years ago. New buildings will not solve the problems of kids that don't want to learn and a home life where parents are not involved. Answer: many kids are learning successfully and would caution people from walking away feeling that the entire RUSD is in chaos. Need to fix social promotion. If a child needs to be held back, they should be. What if nothing changes in 5 years? Answer: there will be changes in 5 years.

Ray Lentz talked about how he feels the Village is dictating his every move while turning their heads on Mr. V.

Stephen Fink was present to talk about the driveway and access road to the proposed Culvers and was told to speak with Development Director Peter Wagner.

Mark Silverman was present about Ordinance 2020-03. He didn't think it was reasonable to put something in place without protection from the developments.

Trustee Martin questioned the unemployment check for past Jt. Park employee Jim Svoboda. Muise said the Village has filed an appeal to the State claiming that he should

not be eligible but in order to not incur additional charges the Village would pay those monies and is obligated.

Trustee Stillman questioned the check payable to Camosy.

Motion was amended by Trustee Stillman to approve the amount less the amount payable to Camosy. Seconded by Trustee Stillman. Motion carried unanimously.
