7A(1) - Approval of A/P checks

Motion by Trustee Wishau to approve the A/P checks as presented in the amount of \$578,303.89. Seconded by Trustee Martin. Motion carried unanimously.

8 - Ordinances and Resolutions

8A - Resolution 2020-22 - Resolution Of The Village Board Of The Village Of Caledonia: Designation Of "Emergency Responder" Employees Under The Families First Coronavirus Response Act

Christensen explained that the Village has the option to designate Emergency Responders who are exempt from the Act. This Resolution identifies the employees who are designated as emergency responders.

Motion by Trustee Stillman to approve Resolution 2020-22. Seconded by Trustee Weatherston. Motion carried unanimously.

8B - Resolution 2020-23 - Resolution Of The Village Board Of The Village Of Caledonia To Ratify The Emergency Proclamation Approved By The Village President Pertaining To The Covid-19 Pandemic And Declaration Of Emergency And All Actions Taken Thereunder Including The Adoption Of The Covid-19 Employment And Employee Conditions Policy, The Families First Coronavirus Response Act: Public Health Emergency Family And Medical Leave Policy Addendum To The Village's FMLA Policy And The Families First Coronavirus Response Act Emergency Paid Sick Leave Policy

Christensen explained that the Board authorized the President to put out an emergency declaration. This Resolution ratifies that emergency declaration and authorizes the policies put in place in that emergency proclamation and formalizes them here. This mirrors the Federal law.

The Original proclamation is through April 17th but given the status the Resolution extends until the emergency powers are terminated by the Village Board. The Board wanted there to be a sunset date, for possibly June, and could be revisited at that time.

Motion by Trustee Martin to approve Resolution 2020-23 with the emergency declaration being effective until June 1st unless further extended by the Board. Seconded by Trustee Weatherston. Motion carried unanimously.

8C - Resolution 2020-24 - Resolution Of The Village Board Of The Village Of Caledonia Disallowing The Claim Of Michelle M. Martin, A Deceased Person, And The Estate Of Michelle M. Martin By William H. Martin As Personal Representative Of The Estate Of Michelle M. Martin Dated March 16, 2020 And Filed With The Village On March 23, 2020

Christensen explained a claim was filed, and the next Resolution is a companion claim. He gave a brief history about what occurred and explained that the in order to move forward in the process, the claim must be denied so that it can move forward to next phase of litigation.

Motion by Trustee Weatherston to approve Resolution 2020-24. Seconded by Trustee Wanggaard. Motion carried unanimously.
