4A - Presentation on County-Wide Sales Tax

Christensen talked about exploring a ½ percent sales tax to help with diversifying our tax base other than through property taxes. Currently, there are only four counties in the State that have not implemented this tax. Many people are paying this tax when they shop anywhere else such as Kenosha and Milwaukee. If this was enacted, a reasonable expectation would be about \$91.69 per capita totaling about \$18 million county-wide. The proposal would be for the County to keep half and the other half would be split between the 17 municipalities. For Caledonia, this would equate to approximately \$46 per person for a total of \$1.15 million. This presentation will be given to all 17 municipalities. A Resolution would be drafted asking the County Board to consider implementing the ½ percent tax. If Caledonia would approve such a tax, an Intergovernmental Agreement would need to be drafted outlining the details to ensure the money gets distributed among all the municipalities because the County could legally keep all of it. The goal would be to distribute the sales tax among each community to help stabilize real estate taxes. Further discussion was held and many questions were asked such as how the other community leaders felt about this proposal. Most approved except a few that wanted more information. The County Executive was not in favor of it. Trustee Martin had some concern with how it would affect the lower income residents because it is regressive. After further discussion, a majority of the Board was not in favor of exploring sales tax any further. No further action taken on this item.

Trustee Prott abstained from discussion/voting on this item. Christensen explained that in order to turn this into a vital regional park it would make sense to have the County operate the park, but the ownership would remain with the Village of Caledonia and Mount Pleasant. Trustee Weatherston explained that the Joint Park Transition Commission explored many options to maintain all the organizations that use this park. Caledonia, with its current staff and funding, is not equipped to run the park in the capacity that is needed. The County Executive agreed that this fits in with the plan being worked on with the Johnson Foundation as a regional park. The Board also discussed including a clause in an Intergovernmental Agreement regarding the timeframe of the Agreement. This was mainly to have some control in the event of improper maintenance and oversight. Some Board members felt if that happened, they would be right back in the same predicament they are now with not enough resources and funds to run the park.

Trustee Wanggaard felt the County does not have the staff to take on another park and questioned why they'd agree to running a park that they do not own. Trustee Martin had concerns with what would happen to the park if it is not adequately taken care of and for that reason would like to see some type of sunset clause in the agreement. Christensen stated that this is not a done deal if the Board approves it. This approval gives the go ahead to move forward with a serious conversation with the County.
