And Its Affiliated Debtors As</u> <u>Recommended By Opioid Litigation Consortium Counsel In Consolidated Claim</u>

This was a follow up discussion that the Board had a few years ago where the Village opted to not pursue an individual claim against any opioid manufactures or distributors but to stay in a negotiation class. In 2020 Purdue Pharma filed bankruptcy and it was recommended by the Consolidation Claim Counsel to file a claim to the Prudue Pharma bankruptcy. The lead was followed like other municipalities that were part of that overall class had done. It is being recommend by the Social Counsel to approve the plan of reorganization and that eventually there will be additional funds that will flow down to the municipality as a part of the overall trust that will be created.

BACKGROUND INFORMATION

The North Kremer Water Main Improvements Project has been designed, reviewed, and publicly advertised as required. The bid opening for the project was held on July 1st. The Caledonia Utility District received 8 bids for the project. The low bid was from PTS Contractors Inc. at \$2,681,000. This bid is approximately \$19,000 or 0.7% below the engineers estimate for the work.

So, the Commission is aware the Concord Apartment Master Water Meter Vault was included in this work. The intent is to obtain the easement and install the vault or change order out the meter vault if the easement is not obtained in an acceptable amount of time.

RECOMMENDATION

LOCATION and Type of PROPOSED WORK: The Caledonia Utility District needs to relay an aging water main within the North Kremer neighborhood and install a water-metering vault in the southeast corner of the Concord Apartments property along North Main Street. The north Kremer neighborhood consists of Chester Lane; Crown Point Drive; Lora Street; Wedgewood Drive; Wind Dale Drive; Elizabeth Street; Meridian Avenue; Parry Avenue; Tanglewood Avenue; and Acacia Drive. Since the existing water main is aging, the solution is to abandon the existing 6" and relay a new upsized 8" water main. Water services will be installed via open cut and trenchless technologies. Special Provisions Related To Caledonia Right-Of-Ways and Easements Only

- 1. Pavement shall be saw cut and removed to the marks provided by the Village Engineering Department. Pavement patches shall have a minimum of 10 inches of compacted acceptable crushed granular base course and a minimum depth of 6 inches of asphalt (4.5" binder and 1.5" finished). The hot mix asphalt shall be placed and compacted in two $-2\frac{1}{4}$ " lifts of binder and one $-1\frac{1}{2}$ " lift of finished asphalt per Village Ordinance. All pavement patches must be completed to the satisfaction of the Caledonia Highway Superintendent. All pavement patches shall be constructed to ensure an even transition to the existing pavement is maintained.
- 2. The thickness of the replacement asphalt in driveway areas shall match the existing pavement thicknesses, but not less than 4". Pavement patches in driveways shall be placed on a minimum of 6" of compacted acceptable crushed granular base course material.
- 3. The Caledonia Utility District shall be responsible to ensure proper compaction of the crushed granular base course. If there are questions about compaction, compaction tests may be required. The contractor will be required to provide their own vehicles for these tests. The Caledonia Utility District will also be responsible to collect asphalt tickets (for quantities) and for checking asphalt temperatures prior to placement. Refer to Wisconsin DOT specifications for asphalt temperatures.
- 4. The Village Engineering Department is to be contacted to attend the preconstruction meeting for this project. Prior to the placement of any asphalt, the contractor shall contact the Caledonia Engineering Department for an inspection to confirm pavement thicknesses. A minimum of 24 hour notice will be required. Prior to final payment the Public Works Director or his representative and the Highway Superintendent are to be contacted to do a final inspection of the project areas with the District Manager, Consulting Engineer and the Contractor. The Public Works Director and Highway Superintendent will determine if the repair / restoration has been made in accord with all specifications and requirements of the Village.
- 5. Hours of operation are to conform to Village ordinances. 7:00 A.M. to 7:00 P.M. Monday thru Friday and 8:00 A.M. to 5:00 P.M. on Saturdays. Work on Sundays must be approved by the Village Board.
- 6. The contractor and/or the Consulting Engineer shall be responsible for communication with all Utilities as necessary for relocation/adjustments of existing Utilities. The contractor and/or the Consulting Engineer shall also be responsible to notify and coordinate possible driveway closures with the affected property owners.
- 7. All traffic control is to be provided, installed, monitored and maintained per the Village ordinances and the MUTCD Handbook. All Village Road closings are to be avoided, but if absolutely necessary a detour plan must be provided to the Village Engineer for review and proper approvals. Flagmen may need to be provided. Proper lighted signage must be installed, monitored and maintained as necessary through the course of this project until normal traffic patterns can be restored. Once work begins it must be continuous until pavement is replaced. Any road closing shall be done in accordance with Village ordinances and the general provisions attached hereto. The contractor and the Consulting Engineer shall make sure that all the property owners, schools and their bus companies, Caledonia Police, Fire and Highway Departments are made aware of the partial road & driveway closings and traffic control plans. All construction and trucking habits must be safe. If problems with poor construction or trucking habits occur, the project may be shut down until otherwise directed by the Village Engineer.
- 8. The 25 replacements submitted are located in the Village of Caledonia road right of ways. If additional patches are added and are located in State, County, or Village of Wind Point road right of ways, proper permits and approvals from the owners shall be required.

- 9. All ditches, drainage ways, and disturbed areas that were excavated, damaged or silted in as a result of the breaks and their repair must be restored to their preconstruction conditions or better. This may require grading from culvert to culvert. Excelsior mat or sod may be required to prevent erosion problems. Proper drainage must be maintained. Culverts and storm sewer systems that were silted in shall be cleaned at the direction of the Public Works and Village Utility Directors.
- 10. Erosion control must be installed and maintained per Wisconsin Construction Site Best Management Practices. Erosion control must be installed at the inlets to road and driveway culverts and any storm sewer inlets located downstream of disturbed areas. Disturbed areas with slopes steeper than 2% will need to be excelsior matted and sod check damns installed per Village standards. All tracking on roadways shall be cleaned up immediately. Contractor must monitor and maintain/provide dust control thru the entire course of this project. Watering may be necessary to keep the dust to a minimum.
- 11. The Contractor will be responsible for the proper disposal of spoil material. If more than 150 cubic yards of spoil material is to be placed in the Village of Caledonia contact the Village Engineering Department for a possible Land Disturbance/Erosion Control Permit.
- 12. All work shall be carried out pursuant to the Foth Infrastructure and Environment, LLC 6-16-21 PE stamped plans and specifications and subject to the attached Village ordinances and specifications. If any changes or additional areas are incorporated to the project, Foth Infrastructure and Environment LLC. must submit proposed revisions to the Caledonia Engineering Department for review and approval prior to construction.
- 13. Pursuant to Village Ordinance 18-1-6-(n) The permittee guarantees its work and shall maintain it for twentyfour (24) months following its completion. During this period it shall, upon notification from the Public Works Director, immediately correct, repair, restore and/or re-do any and all work and portions thereof to the extent required or directed by the Public Works Director, using the method and within the time required by the Public Works Director. Said work shall be completed within ten (10) calendar days or the receipt of the notice from the Village, not including days during which work cannot be done because of circumstances constituting force majeure. If the repair and/or replacement pavement or material settles or cracks within five (5) years of the date of the permit and if the failure and/or replacement is due to improper backfill, compaction or materials, the pavement and backfill in the Excavation area shall be forthwith removed and replaced at the expense of the Permittee.
