**2. Approval of minutes**

**3. Code Enforcement Ability to Write to Tickets**

**4. Ordinance 2022-XX - An Ordinance To Create Section 10-1-9 (D) (26) And To Amend Section 101-9 (F) (11) Of The Code Of Ordinances Of The Village Of Caledonia, Racine County, Wisconsin, Relating To Speed Limits On 4 Mile Road**

Motion by Trustee McManus to recommend approval and forward to the Village Board Ordinance 2022-XX - An Ordinance to create section 10-1-9 (d) (26) and to amend section 10-1-9 (f) (11) to modify the speed limit along 4 mile road between the east frontage road and CTH V to 35 miles per hour. Seconded by Trustee Weatherston. Motion carried unanimously.

**5. Ordinance 2022-XX - An Ordinance To Create Section 10-1-12(P) Of The Code Of Ordinances For The Village Of Caledonia, Racine County, Wisconsin Relating To A Prohibited Parking Zone On Button Bush Drive**

Trustee McManus motioned to approve and recommend to the Village Board that Ordinance 10-1-12 is amended to add the outside lanes of Button Bush Drive to the Parking Prohibited Zones from November 15<sup>th</sup> through April 1<sup>st</sup> of each year and the Highway Department is
