The Commission looked over the minutes from the August 20th meeting and the agendas from the September 17th and September 23rd meetings of the Racine Water Utility.

The Commission looked over the minutes from the August 20th & September 11th meetings and the agendas from the September 11th & September 17th meetings of the Racine Sewer Utility.

Director Bunkelman indicated that the Attorney's from the communities have met, and the ball is in Racine's court to provide information on what the potential change is.

7 – Project Updates

a. Current Contracts

Director Bunkelman discussed the status of the Sundance Heights Watermain Replacement project contract.

b. Riverbend Lift Station Safety Site, Lift Station & Forcemain Upgrade

Facility Plan to be wrapped up at a later date. Project on hold temporarily to not have conflicts with the Highway 38 Bridge Replacement. Riverbend Lift Station Pump #3 out of service. Ordered a new pump, awaiting delivery. Reached out to update delivery. Delivery now approximately October 29, 2024.

c. Annual Televising Program – Sanitary Sewer

Cleaning for 2024 continues. Will be looking to get a quote for lining and grouting the River Meadows area and also need to get quotes for Armorock Manholes and lining of Sanitary Sewer along 3 Mile Road. Looking to place both projects in 2025 budget if possible.

d. Central Lift Station Safety Site & Attenuation Basin

Design of Basin continues. Provided comments on 60% plans. A meeting was held with We Energies to discuss electrical feed for the project.

e. TID #4 Elevated Storage Tank & Adams Road Watermain

Plans submitted to the PSC & DNR for approval. Looking to out to bid in the next couple of months.

f. Western Village / Sundance Heights Watermain

Watermain and services have been completed. Contractor working on restoration. Had field meeting to mark out pavement replacements.

g. TID #4 Phase 4 Sanitary Sewer & Watermain Extension Project

Pre-Construction Meeting held on September 26. Dorner will start the project the week of October 6th. Infrastructure (Sewer & Water) to start on October 13th.

h. Hoods Creek – Aldebaran Brushing Project

Contractor has completed the project to Highway 38 and has only a couple of trees to remove near the lift station. Will be performing a walkthrough soon to ensure final completion.

i. Turtle Creek Restoration

Southern Wisconsin Appraisal meeting with owners to discuss easements. Great Lakes Tree started the Klema Ditch tree removals on September 26th. Have also been in touch with an Arborist to potentially spray the Klema Ditch to prevent tree growth.

j. 4 Mile Road Tile (Club View Subdivision to Erie Street)

Drainage Study is currently underway. Have been providing information to the consultant as requested.

a. 2025 Utility District Budget

Director Bunkelman gave a brief introduction of the 2025 Utility District Budget to the Commission. The Village Board has also reviewed this budget in their budget sessions.

Trustee Wishau made a motion to approve the 2025 Utility District Budget and forward to the Village Board for final approval. Seconded by Commissioner Trentadue. **Motion carried 5-0.**

The meeting was called to order by Commission President Tate II, at 5:15 p.m.

Subject: Communication Sponsored by Alder McCarthy, on behalf of the Waterworks Commission, requesting approval of a Developer's Agreement for the Mount Pleasant TID#7 Development Project (V. Mount Pleasant, developer).

Staff Recommendation: To Approve with a Referral to the Finance & Personnel Committee.

Recommendation of the Waterworks Commission on 08/20/2024:

To Defer this item until more specific information can be gathered to support whether the water usage proposed within this Developer's Agreement would fall under the stipulation of the 9,000 gallons/day/acre as laid out in the 2004 Retail Water Agreement.

Recommendation of the Waterworks Commission on 09/17/2024:

To Defer this item until a more clearer understanding of how the REC (Residential Equipment Charge) fees will impact the financing to cover the estimated over-sizing cost of the water main without it affecting the rate payers.

Recommendation of the Finance and Personnel Committee on

09-23-2024: That the Waterworks Commission be granted permission to approve a Developer's Agreement for the Mount Pleasant TID#7 Development Project (V. Mount Pleasant, developer).

Fiscal Note: The developer pays all costs associated with the installation of the local 12" water main estimated at 2.58M.

The Water Utility Director presented the Request to Approve the Developer's Agreement for the TID#7 Development Project within the Village of Mount Pleasant and reminded everyone of the past voting actions that had been taken on the item at previous meetings. Discussion ensued regarding the purpose of the original plan for over-sizing the water main to 16" and its effect on water flow. The Utility Director presented information on figures and requirements for fire flow for the pipe based on current models, and reiterated how a 12" water main will support the flow for the current Educator's Credit Union and the Springs Development, but cited that the 16" water main was initially recommended by the Chief Utility Engineer in an effort to minimize potential future costs to be incurred by the Utility, while also accommodating potential future growth in the area.

A motion was made by Jorgenson, seconded by Mayor Mason, that this file be Approved. The motion PASSED by a voice vote with 4 AYES and 2 NAY votes recorded.

BACKGROUND INFORMATION

For the TID #4 Phase 4 Sanitary Sewer & Watermain Extensions Project, the Caledonia Utility District needs to obtain a Permanent Sanitary Sewer Easement and a Temporary Limited Easement from Ronald P. Schultz, a property owner along Highway K. These Easements are for the installation of Sanitary Sewer from Highway K to Golf Road for the South Hills Commerce Center Development and other properties.

The Public Services Director met with Mr. Schultz to obtain the Permanent Sanitary Sewer Easement and Temporary Limited Easement. Mr. Schultz agreed to grant the easements and has recently executed the Sanitary Sewer Easement Agreement. Attached is a copy of the agreement.

To complete the Sanitary Sewer Easement Agreement, the signatures of the President & Secretary of the Utility District and signatures of the President and Clerk of the Village Board are required.

RECOMMENDATION

Move to authorize the President and Secretary of the Caledonia Utility District to execute the Sanitary Sewer Easement Agreement with Ronald P. Schultz for the TID #4 Phase 4 Sanitary Sewer and Watermain Extension Project.

SANITARY SEWER EASEMENT AGREEMENT

This **SANITARY SEWER EASEMENT AGREEMENT** (“**Agreement**”) is made and entered into by and between **RONALD P. SCHULTZ** (“**Owner**”), the **CALEDONIA SEWER UTILITY DISTRICT**, and the **VILLAGE OF CALEDONIA**, Racine County, Wisconsin (collectively “**the Village**”) as of the 11 day of October, 2024.

RECITALS

- A. Owner is the fee holder of certain real property located in the Village of Caledonia, County of Racine, State of Wisconsin, which is legally described as:

The North 60 acres of the East ½ of the Northeast ¼ of Section 31, Township 4 North, Range 22 East. EXCEPTING THEREFROM lands conveyed to Racine County by Document No. 909497. Said land being in the Village of Caledonia, County of Racine, State of Wisconsin with Tax Key No. 104-04-22-31-001-000 (“**Parent Parcel**”).

- B. The Village and Owner have negotiated for the acquisition by the Village of a Temporary Limited Easement and a Permanent Sanitary Sewer Easement over portions of the Parent Parcel, all as further described herein and as depicted and described in the attached and incorporated **Exhibit A** hereto.

- C. The easements are necessary because of the installation of sanitary sewer main improvements to extend sewer services within the Village to serve the Parent Parcel as well as adjacent and other parcels in the surrounding area.

AGREEMENT

For the mutual promises contained herein and other good and valuable consideration, the sufficiency of which the parties hereby acknowledged, the parties agree as follows:

1. **Grant of Easements.**

- A. **Permanent Sanitary Sewer Easement.** Owner grants to the Village a perpetual, exclusive sanitary sewer easement on and under a portion of the Parent Parcel legally described and depicted on attached **Exhibit A** as the Permanent Sewer Easement (“**Permanent Sewer Easement Area**”). This grant includes the right to enter, construct, reconstruct, maintain, improve, repair, alter or operate a sanitary sewer within the Permanent Sewer Easement Area and appurtenances, including, without limitation, any/all later modifications or reconstructions thereto, together with right to enter, with all necessary and proper workers, equipment, and materials with respect thereto, for conveying sanitary sewer utility service through, on and under the Permanent Sewer Easement Area, together also with the right to excavate and/or refill ditches and/or trenches as necessary, and to remove such trees, bushes, undergrowth and other obstructions as may interfere with the exercise of this Agreement.

- B. **Temporary Limited Construction Easement.** Owner grants to the Village the following temporary limited construction easement and related easement rights on and over that portion of the Parent Parcel described and depicted on attached **Exhibit A** as the Temporary Limited Easement (the "Temporary Limited Easement Area"):
1. The right to enter and use the Temporary Limited Easement Area for the staging and storage of construction materials, vehicles, and equipment for the construction and installation of the sanitary sewer;
 2. The right to change the slopes and grades of the Temporary Limited Easement Area, so that the same blend in with and conform to the slopes and grades of the finished project topography and to remove trees, bushes or other vegetation.
 3. The finished slopes and grades of the Temporary Limited Easement Area shall be finish-graded by the Village.
 4. The Temporary Limited Easement Area described herein shall cease to exist one (1) year from the date of execution unless released earlier in writing by the Village.
2. **Restoration of Surface.** The Village shall restore the surface disturbed by any construction or maintenance of piping or equipment located within the Permanent Easement Area and Temporary Limited Easement Area to their condition before the disturbance, but the Village shall not be required to restore or replace any trees, bushes and vegetation within such areas that would interfere with the easements granted hereby.
3. **Topsoil on Parent Parcel.** The Village, through the construction of the Project through the Permanent Easement Area and Temporary Limited Easement Area on the Parent Parcel, shall not remove any topsoil from the Parent Parcel. All topsoil that is on the Parent Parcel shall be stockpiled on the Easements and shall be replaced with the same thickness as the original topsoil on the Parent Parcel.
4. **Vibrashank/Chisel Plow Easement Area.** The Owner, directly or through his third parties, is allowed to Vibrashank/Chisel Plow the Easement Areas in the Fall of 2025 after the Village completes the Project.
5. **Deferred Special Assessment.** The Village previously imposed deferred special assessments on the Parent Parcel per Village Resolution No. 2016-45 for Sanitary Sewer and Watermain. The special assessments for this property total \$229,806.75 (the "Special Assessments"). The execution of this Easement Agreement and the granting of the easements thereunder shall not trigger the Special Assessments to become payable to the Village.
6. **Reserved Rights.** The Owner retains the full right to use the Permanent Sewer Easement Area and Temporary Limited Easement Area, including all areas at, above or below grade, subject only to the reasonable exercise of the Village's rights under this Agreement and the Village's right to review and approve the location of any proposed improvements within the Permanent Sewer Easement Area including, but not limited to, a driveway or other means of accessing the

Parent Parcel. The Village's reviews and approvals for such driveways or any other proposed improvements shall be made by the Village Engineer and approval shall not be unreasonably withheld or delayed.

7. **Covenants Run with Land.** All of the terms and conditions in this Agreement, including the benefits and burdens, shall run with the land and shall be binding upon, inure to the benefit of, and be enforceable by the Owner and the Village and their respective successors and assigns. The Village shall cause this Agreement to be recorded in the office of the Register of Deeds for Racine County, Wisconsin.
8. **Non-use.** Non-use or limited use of the easement rights granted in this Agreement shall not prevent the benefiting party from later use of the easement rights to the fullest extent authorized in this Agreement.
9. **Governing Law.** This agreement shall be construed and enforced in accordance with the laws of the State of Wisconsin. Venue for any legal action pertaining to and/or arising under this Agreement shall solely and exclusively be Racine County Circuit Court in Racine County, Wisconsin.
10. **Entire Agreement.** This Agreement sets forth the entire understanding of the parties and may not be changed except by a written document executed and acknowledged by all parties to this Agreement and duly recorded in the office of the Register of Deeds for Racine County, Wisconsin.

IN WITNESS WHEREOF, the above-named parties, either personally or through their duly authorized officers, have executed this Agreement as of the date indicated above.

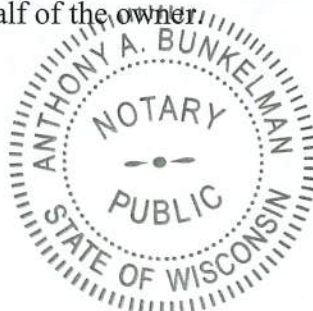

RE: Unwritten Caledonia Utility District Policies

BACKGROUND INFORMATION

The Caledonia Utility District has been compiling a list of unwritten policies that should be incorporated into the Caledonia Utility Standard Specifications. The list of unwritten polies consists of the following:

- No Sanitary Laterals into sanitary manholes.
- Sanitary Laterals have cleanouts installed at the Right of Way line
- Sanitary Lateral minimum size 4" or 6"
- Televising Sanitary Laterals from the Right of Way back to the house and providing a copy of the video to the District
- Half & Full Lane replacement of asphalt pavement
- Slurry Backfill Only roads listed or referenced
- Update nomenclature for Asphalt Pavement
- Concrete Pavement replacement specifications to match Caledonia specifications
- Install asphalt driveway aprons back to Right of Way line (even on gravel driveways)
- Working Hours for Contractors
- Including additional water service sizes (currently only 1 1/4")
- Come up with a consistent sanitary sewer lateral riser detail
- Storm Water Pond Outlet Standard Detail (Size, Material, Orifice, Grates, etc.)
- Storm Water Pond grading standards (4:1 slopes above water surface, 10:1 safety shelf, 3:1 slopes under water surface.
- Storm Water Pond Emergency Overflow Wier Standard
- Storm Water Pond water surface elevation freeboard requirements
- Sanitary Sewer Manhole (Armorock or equal)
- Hymax Watermain Couplings

RECOMMENDATION

Have staff review the unwritten policies and update the Caledonia Standard Specifications as necessary.
