Village Staff and Chris Rubacha from Ashley Ventures presented the development agreement and answered questions from the Board. Staff advised there were a few minor provisions of the agreement still being worked out addressing infrastructure as required by the Village's Code of Ordinances, but the overall material terms of the development agreement have not changed since last presented to the Village Board in closed session and are included in the provisions of the development agreement before the Village Board has been finalized. Village Staff presented on the material terms of the agreement. Trustee Martin expressed reservations in approving the item by giving authorization to staff to finalize the remaining provisions but that she is otherwise in favor of the agreement.

#### RESOLUTION NO. 2024-091 VILLAGE OF CALEDONIA

## A RESOLUTION APPROVING WAIVING REZONING FEES, INCLUDING THE COST OF PUBLICATION, FOR PROPERTIES IN A LEGACY ZONING DISTRICT.

The Village Board of the Village of Caledonia, Racine County, Wisconsin do resolve as follows:

WHEREAS, in October of 2022, the Village Board approved Ordinance 2022-23 to amend the zoning districts within the Village and to grandfather all legal lots, land uses, and structures existing prior to the adoption of ordinance 2022-23. Such grandfathered zoning districts are also known as "Legacy Zoning Districts"; and

WHEREAS, the Village charges fees to apply to rezone a property and such fees are amended from time to time by resolution of the Village Board; and

WHEREAS, owners of parcels in Legacy Zoning Districts occasionally voluntarily rezone their properties to the corresponding current zoning district and are charged application fees for rezoning the property; and

WHEREAS, Village staff want to support the requests of owners who desire to voluntarily rezone their properties to a current zoning district which facilitates good administration of the zoning districts;

WHEREAS, Village staff recommends that the Village waive application fees associated with a rezone, including the cost of publication, for owners of Legacy Zoning District parcels that apply to rezone their property to the corresponding current zoning district, thereby conforming to the current zoning code;

**NOW, THEREFORE, BE IT RESOLVED** by the Village Board of the Village of Caledonia that all rezoning fees, including the cost of publication, shall be waived for owners of properties zoned in a Legacy Zoning District provided the owners are rezoning their properties to the corresponding zoning district in the current zoning code in an effort to conform with the current zoning code.

#### RESOLUTION NO. 2024-092 VILLAGE OF CALEDONIA

# A RESOLUTION AUTHORIZING THE VILLAGE OF CALEDONIA TO EXECUTE A STORM WATER RETENTION POND EASEMENT AGREEMENT AND A STORM WATER BIO FILTER BASIN EASEMENT AGREEMENT WITH THE RACINE UNIFIED SCHOOL DISTRICT

The Village Board for the Village of Caledonia, Racine County, WI do resolve as follows:

WHEREAS, the Caledonia Utility District has conditionally approved a Storm Water Management Plan and a Site Grading Plan for Racine Unified School District for the construction of a building addition at Olympia Brown School, 2115 5 ½ Mile Road. As a condition of approval of the Storm Water Management Plan and Site Grading Plan, the Storm Water Easements were required to be granted over the expanded Storm Water Retention Pond and expanded Storm Water Bio Filter Basin.

**WHEREAS**, the Village has prepared said Storm Water Retention Pond Easement Agreement and Storm Water Bio Filter Basin Easement Agreement.

**WHEREAS**, the Owner, the Racine Unified School District has executed both the Storm Water Retention Pond Easement Agreement and Storm Water Bio Filter Basin Easement Agreement.

**WHEREAS,** the Caledonia Utility District has authorized the President & Secretary of the Caledonia Utility District to execute both the Storm Water Retention Pond Easement Agreement and Storm Water Bio Filter Basin Easement Agreement at their August 7, 2024 meeting.

WHEREAS, the President and Clerk of the Village need to execute both the Storm Water Retention Pond Easement Agreement and Storm Water Bio Filter Basin Easement Agreement in order to allow them to be recorded.

**NOW, THEREFORE, BE IT RESOLVED** by the Caledonia Village Board that the execution of the Storm Water Retention Pond Easement Agreement as set forth in Exhibit A, which is attached hereto and incorporated herein by reference, is approved and that the Village President and Village Clerk are authorized to execute said Storm Water Retention Pond Easement Agreement.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** by the Caledonia Village Board that the execution of the Storm Water Bio Filter Basin Easement Agreement as set forth in Exhibit B, which is attached hereto and incorporated herein by reference, is approved and that the Village President and Village Clerk are authorized to execute said Storm Water Bio Filter Basin Easement Agreement.

### STORM WATER RETENTION POND AND EASEMENT AGREEMENT: RACINE UNIFIED SCHOOL DISTRICT

This Storm Water Retention Pond a	and Easement Agreement ("Agreement") is made this
24 day of \uly	, 2024, by and between the RACINE UNIFIED
SCHOOL DISTRICT, a Wisconsin r	municipal entity referred to in this Agreement as "Owner",
	A, Racine County, Wisconsin, and the VILLAGE OF
<b>CALEDONIA UTILITY DISTRICT, </b>	a utility district of the Village of Caledonia, Racine County,
Wisconsin. The Village of Caledon	ia and Village of Caledonia Utility District are collectively
referred to in this Agreement as the	"Grantees".

#### **RECITALS**

- A. The Owner is the fee simple holder of certain real property in the Village of Caledonia, Racine County, State of Wisconsin, as more particularly described and depicted on Exhibit A, and hereby incorporated herein by reference. Said real property is referred to in this Agreement as the "Property".
- B. As a part of the approval by the Grantees of the improvement of the Property, the Grantees have required the Owner to construct/enlarge, at their own cost and expense, a storm water retention pond, that will serve as a part of the storm water drainage facilities on the Property described and depicted on Exhibit B attached hereto and incorporated herein. Said storm water retention pond is referred to in this Agreement as the "Retention Pond". The Grantees have further required as part of said approval that the Owner enter into an agreement with Grantees setting forth the Owner's responsibility to maintain the Retention Pond and provide Grantees with an access easement.
- C. The Grantees have requested that the Owner grant a permanent easement over that portion of the Property described in attached Exhibit B, hereinafter referred to in this Agreement as the "Pond Easement Area". The location of the Pond Easement Area with respect to the Property is as shown and described in Exhibit B.
- D. The Grantees have requested that the Owner grant a permanent easement (referred to in this Agreement as the "Access Easement") over the Property, as may be necessary for the Grantees to exercise their rights under this Agreement.
- E. As used in this Agreement, the term "Drainage Facilities" shall mean the Retention Pond, Access Easement, drainage swales, drainage ditches, pipelines, laterals, culverts, storm sewers and any other structures or improvements that are constructed or installed upon the Pond Easement Area and/or other areas of the Property from time to time by the Owner or Grantees, or any other person or entity, or their contractors, successors and assigns, for the conveyance of surface and storm waters over, across, under and through the Property.

#### **AGREEMENT**

For \$1.00 and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

- 1. <u>Construction, Use, Operation, Cleaning, Maintenance, Altering, Repairs and Replacements of Retention Pond and Drainage Facilities</u>. The Owner agrees to construct, use, operate, clean, maintain, alter, repair and replace the Retention Pond and Drainage Facilities, including, without limitation, mowing, control of weed and algae growth, repair of erosion, and the removal of trees, brush, vegetation and silt, and all other obstacles to the flow of surface water to and from the Retention Pond and Drainage Facilities, so that the Retention Pond and Drainage Facilities function properly and to their design capacity for the storage and conveyance of storm water and so that there are no obstructions interfering with the location, construction, use, operation, cleaning, maintenance, alteration, repair and replacement of the Retention Pond and Drainage Facilities. Said obligations shall include the obligation to construct, use, operate, clean, maintain, alter, repair and replace the Retention Pond and Drainage Facilities both during the construction thereof and thereafter and in conformity with this Agreement and the Ordinances of the Village of Caledonia and any restrictive covenants applicable to the Property. The Owner shall prevent the Retention Pond and Drainage Facilities from becoming a nuisance.
- Failure to Construct, Clean, Maintain, Alter, Repair and Replace Retention Pond and Drainage Facilities. The Grantees shall have the right, but not the responsibility, to enter upon the Property in order to perform construction, cleaning, maintenance, alterations, repairs and replacements of the Retention Pond and Drainage Facilities if the Owner fails to do so after receiving a written request from the Grantees. The Owner shall be given at least ten business days after the date of said written request to perform whatever construction, cleaning, maintenance, alterations, repairs and replacements are deemed reasonable and necessary by the Grantees as stated in said notice. Provided, however, that in the event the Grantees determine that emergency action should be performed, then the Grantees may enter upon the Property immediately and perform said emergency action. The Owner shall reimburse Grantees for all costs incurred by the Grantees in performing said construction, cleaning, maintenance, alterations, repairs, replacements and emergency action, including, without limitation, any construction, engineering, legal and administrative costs with respect to the same, upon receiving an invoice for said costs. If Owner fails to pay said costs, then said costs may be assessed upon the Property by the Grantees as a special charge as provided in Wisconsin Statutes Sections 66.0627 and 66.0703, and Owner consents to said assessments and waives notice and hearing with respect to the levying of said assessments in accordance with Wisconsin Statutes Section 66.0703 and/or 66.0627.
- 3. <u>Alteration or Changes of Retention Pond or Drainage Facilities</u>. The Owner shall not make or construct any alteration or change of the Retention Pond or Drainage Facilities, including, without limitation, any alteration or change in the size, shape, capacity, rate of inflow or rate of outflow of the Retention Pond or Drainage Facilities, unless the Grantees approve the alteration or change in writing prior to the making or construction of said alteration or change.
- 4. <u>Indemnification</u>. Owner shall, and hereby does, indemnify and hold harmless the Grantees, and their employees, officials, commissioners, contractors, consultants, and agents from and against any claims, actions, judgments, damages, costs, and expenses (including, but not limited to, reasonable actual attorney fees) and/or liability of any nature whatsoever, that may arise, directly or indirectly, as a result of (i) the existence,

construction, use, operation, cleaning, maintaining, alteration, repair, and/or replacement of the Drainage Facilities and/or the Pond Easement Area, and/or (ii) any property damage and/or bodily injury (including death) that may arise or occur as a result of the foregoing and/or at such locations.

- 5. <u>Insurance</u>. Owner shall, at Owner's own cost and expense, and prior to the construction of the Retention Pond, and any other Drainage Facilities, obtain and maintain a policy of general liability insurance, from a Wisconsin-licensed insurance carrier, that (i) has coverage and policy limits satisfactory to the Grantees, and (ii) has the Grantees named as additional insureds. Such insurance shall be kept and maintained by the Owner throughout the entire term of this Agreement.
- 6. <u>Grant of Easement</u>. The Owner hereby grants to the Grantees, and to the Grantees' employees, officials, commissioners, contractors, consultants, agents, successors, and assigns, a permanent easement and right-of-way over the Property, to and from 5 ½ Mile Road and the Pond Easement Area, for the purposes of (i) performing its duties, responsibilities, and easement rights imposed upon and/or granted to the Grantees under this Agreement, and/or (ii) inspecting, monitoring, and/or testing the Drainage Facilities and/or the Pond Easement Area, and (iii) for conveying and/or storing surface and storm waters in, over, across, under, and/or through the Pond Easement Area and the Drainage Facilities.
- 7. Removal of Obstructions. Owner hereby grants to the Grantees, and to Grantees' employees, officials, commissioners, contractors, consultants, and agents the right to:
  - (a) Cut down and remove or trim all trees, bushes or other vegetation existing within the Pond Easement Area, and to cut down and remove or trim all trees, bushes and other vegetation located outside of the Pond Easement Area that interfere with (i) the construction, use, operation, cleaning, maintenance, alteration, repair and replacement of the Drainage Facilities within the Pond Easement Area, or (ii) ingress and egress to the Pond Easement Area and 5 ½ Mile Road.
  - (b) Remove any fences, structures or improvements located within the Pond Easement Area to the extent necessary to (i) carry out the construction, use, operation, cleaning, maintenance, alteration, repair and replacement of the Drainage Facilities within the Pond Easement Area, or (ii) maintain ingress and egress to the Pond Easement Area and 5 ½ Mile Road.

#### 8. Further Owner Requirements.

- (a) No fences, structures or improvements will be erected, and no trees, bushes or other vegetation will be planted, within the Pond Easement Area without the written consent of the Grantees; and
- (b) The elevation of the existing ground surface within the Pond Easement Area will not be altered without the written consent of the Grantees.
- (c) Owner shall perform the other drainage work in the manner described in attached Exhibit B.

- (d) Owner shall comply with (i) the provisions and requirements of the Storm Water Management Plan for the Property, prepared by Harwood Engineering Consultants, Ltd, dated April 5, 2024 and Professional Engineer Stamped May 31, 2024 and the Construction Plans for the Olympia Brown Elementary Addition & Renovation, prepared by Harwood Engineering Consultants, Ltd, dated and Professional Engineer Stamped May 31, 2024 as may be approved and/or amended from time to time by the Grantees.
- 9. Restoration of Surface. The Grantees shall reasonably restore the surface of the Property disturbed by the Grantees' (i) construction, use, operation, cleaning, maintenance, alteration, repair and replacement of the Retention Pond and Drainage Facilities within the Pond Easement Area or (ii) ingress and egress to the Pond Easement Area. Said restoration shall be to the condition that existed prior to the Grantees' entry on the Property; provided, however that the Grantees shall only be required to (i) restore any disturbed areas of soil with grass seed, and (ii) restore any disturbed paved portion or gravel portion of the Property with similar materials.
- 10. <u>Non-Use</u>. Non-use or limited use of the rights granted to the Grantees in this Agreement shall not prevent the Grantees from the later use of said rights to the fullest extent authorized in this Agreement.
- 11. <u>Covenants Run With Land</u>. All of the terms and conditions in this Agreement, including the benefits and burdens, shall run with the land that is the Property and shall be binding upon, inure to the benefit of, and be enforceable by the Owner and the Grantees and their respective successors and assigns.
- 12. <u>Warranty</u>. The Owner does hereby warrant and covenant that the Owner owns the Property in fee simple and is lawfully seized and possessed of the Property; that the Owner has a good and lawful right to grant the rights granted to the Grantees hereunder; that the Property is free and clear of all liens and encumbrances, except for recorded easements and recorded covenants, that the persons executing this Agreement on behalf of the Owner are fully authorized to execute this Agreement on behalf of the Owner; and that this Agreement is the binding obligation of the Owner.
- 13. <u>Term</u>. The term of this Agreement shall continue indefinitely, in full force and effect, unless and until amended and/or terminated with the written approval of the Grantees.

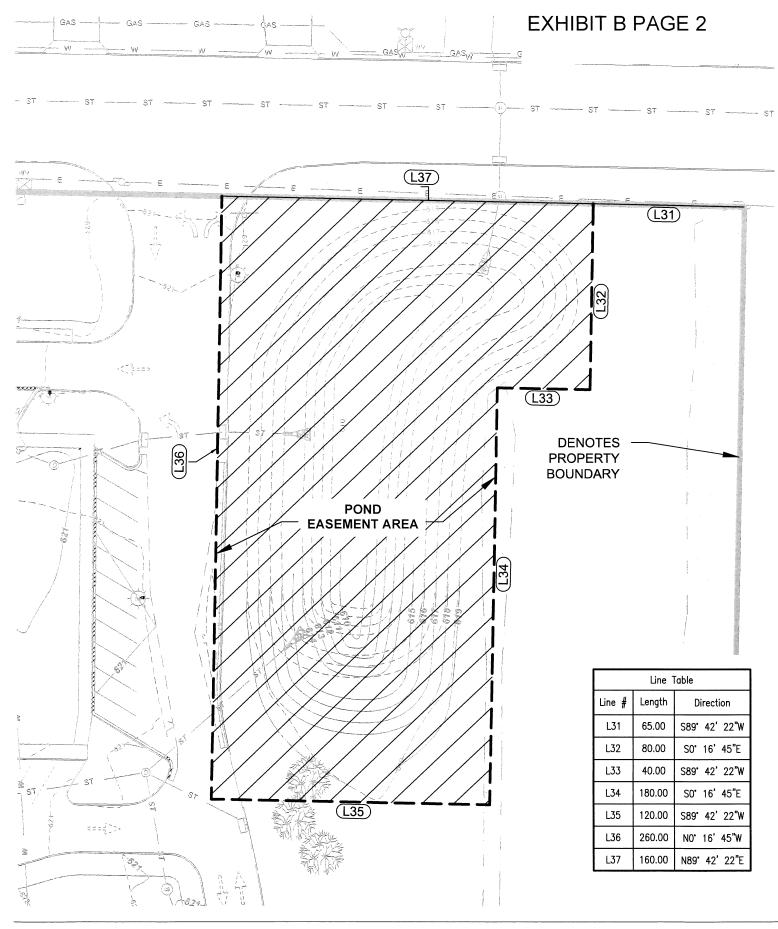

### STORM WATER BIO FILTER BASIN AND EASEMENT AGREEMENT: RACINE UNIFIED SCHOOL DISTRICT

This Storm Water Bio Filter Basin	n and Easement Agreement ("Agreement") is made this
241 day of July	, 2024, by and between the RACINE UNIFIED
	in municipal entity referred to in this Agreement as "Owner",
and the VILLAGE OF CALEDOI	NIA, Racine County, Wisconsin, and the VILLAGE OF
<b>CALEDONIA UTILITY DISTRIC</b>	T, a utility district of the Village of Caledonia, Racine County
Wisconsin. The Village of Caled	onia and Village of Caledonia Utility District are collectively
referred to in this Agreement as	the "Grantees".

#### **RECITALS**

- A. The Owner is the fee simple holder of certain real property in the Village of Caledonia, Racine County, State of Wisconsin, as more particularly described and depicted on Exhibit A, and hereby incorporated herein by reference. Said real property is referred to in this Agreement as the "Property".
- B. As a part of the approval by the Grantees of the improvement of the Property, the Grantees have required the Owner to construct/enlarge, at their own cost and expense, a storm water bio filter basin, that will serve as a part of the storm water drainage facilities on the Property described and depicted on Exhibit B attached hereto and incorporated herein. Said storm water bio filter basin is referred to in this Agreement as the "Bio Filter Basin". The Grantees have further required as part of said approval that the Owner enter into an agreement with Grantees setting forth the Owner's responsibility to maintain the Bio Filter Basin and provide Grantees with an access easement.
- C. The Grantees have requested that the Owner grant a permanent easement over that portion of the Property described in attached Exhibit B, hereinafter referred to in this Agreement as the "Bio Filter Basin Easement Area". The location of the Bio Filter Basin Easement Area with respect to the Property is as shown and described in Exhibit B.
- D. The Grantees have requested that the Owner grant a permanent easement (referred to in this Agreement as the "Access Easement") over the Property, as may be necessary for the Grantees to exercise their rights under this Agreement.
- E. As used in this Agreement, the term "Drainage Facilities" shall mean the Bio Filter Basin, Access Easement, drainage swales, drainage ditches, pipelines, laterals, culverts, storm sewers and any other structures or improvements that are constructed or installed upon the Bio Filter Basin Easement Area and/or other areas of the Property from time to time by the Owner or Grantees, or any other person or entity, or their contractors, successors and assigns, for the conveyance of surface and storm waters over, across, under and through the Property.

#### **AGREEMENT**

For \$1.00 and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

- 1. Construction, Use, Operation, Cleaning, Maintenance, Altering, Repairs and Replacements of Bio Filter Basin and Drainage Facilities. The Owner agrees to construct, use, operate, clean, maintain, alter, repair and replace the Bio Filter Basin and Drainage Facilities, including, without limitation, mowing, control of weed and algae growth, repair of erosion, and the removal of trees, brush, vegetation and silt, and all other obstacles to the flow of surface water to and from the Bio Filter Basin and Drainage Facilities, so that the Bio Filter Basin and Drainage Facilities function properly and to their design capacity for the storage and conveyance of storm water and so that there are no obstructions interfering with the location, construction, use, operation, cleaning, maintenance, alteration, repair and replacement of the Bio Filter Basin and Drainage Facilities. Said obligations shall include the obligation to construct, use, operate, clean, maintain, alter, repair and replace the Bio Filter Basin and Drainage Facilities both during the construction thereof and thereafter and in conformity with this Agreement and the Ordinances of the Village of Caledonia and any restrictive covenants applicable to the Property. The Owner shall prevent the Bio Filter Basin and Drainage Facilities from becoming a nuisance.
- Failure to Construct, Clean, Maintain, Alter, Repair and Replace Bio Filter Basin and Drainage Facilities. The Grantees shall have the right, but not the responsibility, to enter upon the Property in order to perform construction, cleaning, maintenance, alterations, repairs and replacements of the Bio Filter Basin and Drainage Facilities if the Owner fails to do so after receiving a written request from the Grantees. The Owner shall be given at least ten business days after the date of said written request to perform whatever construction, cleaning, maintenance, alterations, repairs and replacements are deemed reasonable and necessary by the Grantees as stated in said notice. Provided, however, that in the event the Grantees determine that emergency action should be performed, then the Grantees may enter upon the Property immediately and perform said emergency action. The Owner shall reimburse Grantees for all costs incurred by the Grantees in performing said construction, cleaning, maintenance, alterations, repairs, replacements and emergency action, including, without limitation, any construction, engineering, legal and administrative costs with respect to the same, upon receiving an invoice for said costs. If Owner fails to pay said costs, then said costs may be assessed upon the Property by the Grantees as a special charge as provided in Wisconsin Statutes Sections 66.0627 and 66.0703, and Owner consents to said assessments and waives notice and hearing with respect to the levving of said assessments in accordance with Wisconsin Statutes Section 66.0703 and/or 66.0627.
- 3. <u>Alteration or Changes of Bio Filter Basin or Drainage Facilities</u>. The Owner shall not make or construct any alteration or change of the Bio Filter Basin or Drainage Facilities, including, without limitation, any alteration or change in the size, shape, capacity, rate of inflow or rate of outflow of the Bio Filter Basin or Drainage Facilities, unless the Grantees approve the alteration or change in writing prior to the making or construction of said alteration or change.
- 4. <u>Indemnification</u>. Owner shall, and hereby does, indemnify and hold harmless the Grantees, and their employees, officials, commissioners, contractors, consultants, and agents from and against any claims, actions, judgments, damages, costs, and expenses (including, but not limited to, reasonable actual attorney fees) and/or liability of any nature whatsoever, that may arise, directly or indirectly, as a result of (i) the existence, construction, use, operation, cleaning, maintaining, alteration, repair, and/or replacement of the Drainage Facilities and/or the Bio Filter Basin Easement Area, and/or (ii) any property damage and/or bodily injury (including

death) that may arise or occur as a result of the foregoing and/or at such locations.

- 5. <u>Insurance</u>. Owner shall, at Owner's own cost and expense, and prior to the construction of the Bio Filter Basin, and any other Drainage Facilities, obtain and maintain a policy of general liability insurance, from a Wisconsin-licensed insurance carrier, that (i) has coverage and policy limits satisfactory to the Grantees, and (ii) has the Grantees named as additional insureds. Such insurance shall be kept and maintained by the Owner throughout the entire term of this Agreement.
- 6. <u>Grant of Easement</u>. The Owner hereby grants to the Grantees, and to the Grantees' employees, officials, commissioners, contractors, consultants, agents, successors, and assigns, a permanent easement and right-of-way over the Property, to and from 5 ½ Mile Road and the Bio Filter Basin Easement Area, for the purposes of (i) performing its duties, responsibilities, and easement rights imposed upon and/or granted to the Grantees under this Agreement, and/or (ii) inspecting, monitoring, and/or testing the Drainage Facilities and/or the Bio Filter Basin Easement Area, and (iii) for conveying and/or storing surface and storm waters in, over, across, under, and/or through the Bio Filter Basin Easement Area and the Drainage Facilities.
- 7. <u>Removal of Obstructions</u>. Owner hereby grants to the Grantees, and to Grantees' employees, officials, commissioners, contractors, consultants, and agents the right to:
  - (a) Cut down and remove or trim all trees, bushes or other vegetation existing within the Bio Filter Basin Easement Area, and to cut down and remove or trim all trees, bushes and other vegetation located outside of the Bio Filter Basin Easement Area that interfere with (i) the construction, use, operation, cleaning, maintenance, alteration, repair and replacement of the Drainage Facilities within the Bio Filter Basin Easement Area, or (ii) ingress and egress to the Bio Filter Basin Easement Area and 5 ½ Mile Road.
  - (b) Remove any fences, structures or improvements located within the Bio Filter Basin Easement Area to the extent necessary to (i) carry out the construction, use, operation, cleaning, maintenance, alteration, repair and replacement of the Drainage Facilities within the Bio Filter Basin Easement Area, or (ii) maintain ingress and egress to the Bio Filter Basin Easement Area and 5 ½ Mile Road.

#### 8. Further Owner Requirements.

- (a) No fences, structures or improvements will be erected, and no trees, bushes or other vegetation will be planted, within the Bio Filter Basin Easement Area without the written consent of the Grantees; and
- (b) The elevation of the existing ground surface within the Bio Filter Basin Easement Area will not be altered without the written consent of the Grantees.
- (c) Owner shall perform the other drainage work in the manner described in attached Exhibit B.
- (d) Owner shall comply with (i) the provisions and requirements of the Storm Water Management Plan for the Property, prepared by Harwood Engineering Consultants, Ltd, dated April 5, 2024 and Professional Engineer Stamped May 31, 2024 and the Construction Plans

for the Olympia Brown Elementary Addition & Renovation, prepared by Harwood Engineering Consultants, Ltd, dated and Professional Engineer Stamped May 31, 2024 as may be approved and/or amended from time to time by the Grantees.

- 9. Restoration of Surface. The Grantees shall reasonably restore the surface of the Property disturbed by the Grantees' (i) construction, use, operation, cleaning, maintenance, alteration, repair and replacement of the Bio Filter Basin and Drainage Facilities within the Bio Filter Basin Easement Area or (ii) ingress and egress to the Bio Filter Basin Easement Area. Said restoration shall be to the condition that existed prior to the Grantees' entry on the Property; provided, however that the Grantees shall only be required to (i) restore any disturbed areas of soil with grass seed, and (ii) restore any disturbed paved portion or gravel portion of the Property with similar materials.
- 10. <u>Non-Use</u>. Non-use or limited use of the rights granted to the Grantees in this Agreement shall not prevent the Grantees from the later use of said rights to the fullest extent authorized in this Agreement.
- 11. <u>Covenants Run With Land</u>. All of the terms and conditions in this Agreement, including the benefits and burdens, shall run with the land that is the Property and shall be binding upon, inure to the benefit of, and be enforceable by the Owner and the Grantees and their respective successors and assigns.
- 12. <u>Warranty</u>. The Owner does hereby warrant and covenant that the Owner owns the Property in fee simple and is lawfully seized and possessed of the Property; that the Owner has a good and lawful right to grant the rights granted to the Grantees hereunder; that the Property is free and clear of all liens and encumbrances, except for recorded easements and recorded covenants, that the persons executing this Agreement on behalf of the Owner are fully authorized to execute this Agreement on behalf of the Owner; and that this Agreement is the binding obligation of the Owner.
- 13. <u>Term.</u> The term of this Agreement shall continue indefinitely, in full force and effect, unless and until amended and/or terminated with the written approval of the Grantees.

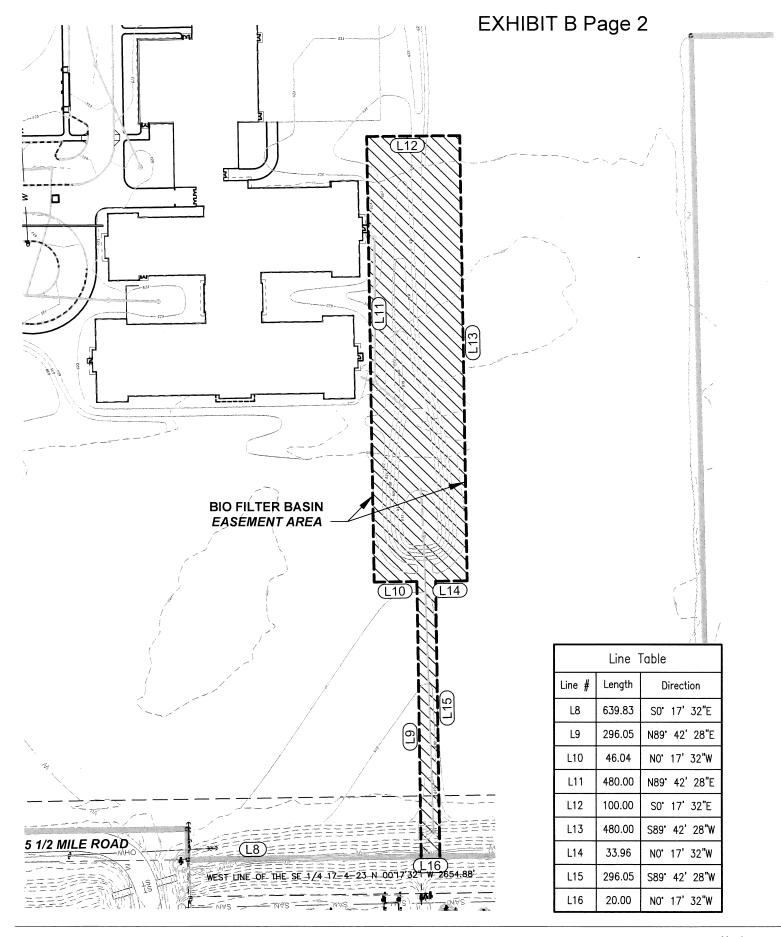

**WHEREAS**, the Police Chief has the authority to order a Police Officer to cover the shift if a volunteer does not fill the shift.

**WHEREAS**, the Police Department would prefer to fill overtime opportunities with volunteers, rather than order officers to work outside of their normal hours.

**WHEREAS**, exempt command staff members of the Police Department have expressed an interest in volunteering for the unfilled overtime assignments *after* the shifts have been offered to subordinate personnel and the shift remains unfilled.

**NOW, THEREFORE, BE IT RESOLVED** that the Village Board hereby approves the following policy related to voluntary overtime shifts within the Police Department:

"At the discretion of the Chief of Police, and with approval from the Chief of Police or his designee, in situations where there is an overtime assignment that needs to be filled, and there are no current subordinate staff (officers, detectives, sergeants, etc.) members who are qualified, able, or willing to voluntarily work the overtime assignment, the assignment may be filled by a member of the command staff (i.e. Lieutenants, Deputy Chief, etc.) working outside of their regular work hours. A command staff member working a posted overtime shift will be paid time and one-half overtime at the highest Sergeant overtime rate for these hours."

# MEMORANDUM OF UNDERSTANDING AMONG THE VILLAGE OF CALEDONIA, VILLAGE OF MOUNT PLEASANT AND ASHLEY VENTURES, LLC

THIS MEMORANDUM OF UNDERSTANDING ("MOU") is made and enter	ed into by
and among the Village of Caledonia, Wisconsin ("Caledonia"), the Village of Moun	t Pleasant,
Wisconsin ("Mount Pleasant") and Ashley Ventures, LLC ("Ashley") as of this	day of
, 2024.	

WHEREAS, the purpose of this MOU is to establish and memorialize the framework, scope of work and responsibilities associated with the future development of a proposed public roadway that is approximately a 66' x 2400' outlined in red on Exhibit A attached hereto (the "Roadway"), with the centerline of the Roadway to running along the municipal boundary between the Village of Caledonia and the Village of Mount Pleasant through parcels of land located at the southern end of the development commonly known as South Hills Commerce Center (as is further described on Exhibit B attached hereto, the "Property"), and

WHEREAS, the Property is currently owned by Hintz Real Estate Development Company ("Hintz"), and

WHEREAS, Ashley and Hintz have entered into a Purchase & Sale Agreement (the "Purchase Agreement") dated October 24, 2023 for the sale of the Property by Hintz to Ashley. The northern thirty-three feet (33') of the Roadway is located in the Village of Caledonia (the "Caledonia Right-of-Way"), and the southern thirty-three feet (33') of the Roadway is located in Mount Pleasant (the "Mount Pleasant Right-of-Way"), and

WHEREAS, Ashley and Caledonia have entered into an Agreement for the development of South Hills Commerce Center for parcels of land in Caledonia, including the portion of the Property that is located in Caledonia ("South Hills Commerce Center") which also addresses the Roadway.

NOW, THEREFORE, in consideration of the mutual understandings set forth above and agreements set forth herein, the Parties hereto agree as follows:

- 1. At a time to be determined by Ashley, and as part of a future phase of South Hills Commerce Center after its acquisition of the Property from Hintz, Ashley shall dedicate the area comprising the Roadway as follows (i) the Caledonia Right-of-Way to Caledonia, \ and (ii) the Mount Pleasant Right-of-Way to Mount Pleasant, Both Caledonia and Mount Pleasant agree to accept such dedication.
- 2. At a time to be determined by Ashley and as part of a future phase of South Hills Commerce Center after its acquisition of the Property from Hintz, Ashley shall construct the Roadway. The Roadway shall be constructed in accordance with the Village of Caledonia Code

of Ordinances, approved plans and specification, the Development Agreement, and the terms and conditions that are set forth on Exhibit C attached hereto.

- 3. Upon substantial completion of the construction of the Roadway in accordance with the Development Agreement, Caledonia and Mount Pleasant shall accept the construction of the Roadway.
- 4. After the dedications and construction described in Sections 1 to 3 above, the Roadway shall be maintained by Caledonia and Mount Pleasant in accordance with the parameters set forth on Exhibit C attached hereto.
- 5. Caledonia and Mount Pleasant agree to cooperate in good faith with Ashley in all matters pertaining to the dedications of the Caledonia Right-of-Way and Mount Pleasant Right-of-Way and the construction of the Roadway.
- 6. All costs for the dedication and construction of the Roadway shall be borne by Ashley.

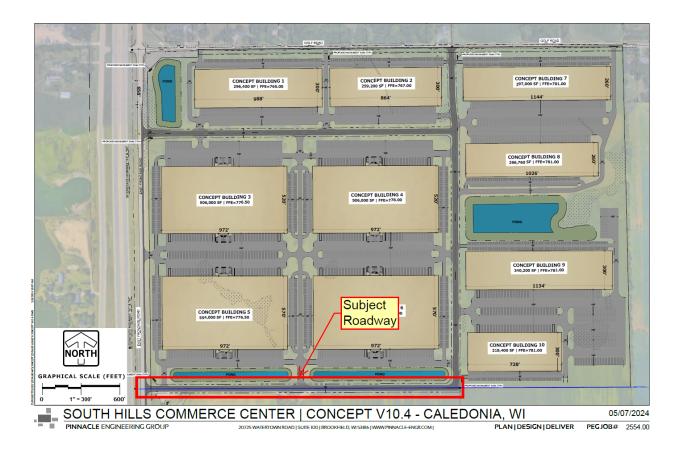

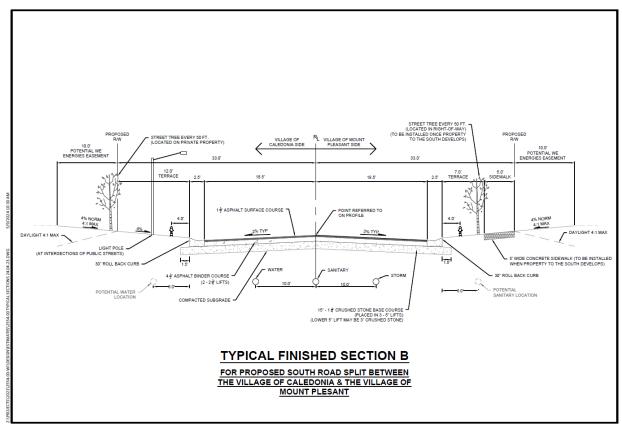
#### **EXHIBIT C**

Terms and Conditions for Construction and Maintenance of Roadway

- 1. The proposed public Roadway will be constructed within a 66-foot right-of-way to the standards established in the Typical Cross-Section included as <u>Exhibit D</u>.
- 2. Sidewalks will not be required within the right-of-way along the northern half of the Roadway in the Village of Caledonia.
- 3. Sidewalks and landscaping will not be required within the right-of-way along the southern half of the Roadway in the Village of Mount Pleasant; however, if the parcel to the south is developed in the future, Mount Pleasant will require the future developer of the southern parcel to install sidewalks and landscaping in conjunction with their development.
- 4. Ashley will dedicate and construct the roadway as a part of the South Hills Commerce Center development. Construction of this roadway is anticipated to be complete by 2035.
- 5. Upon dedication and acceptance of the Roadway, the Village of Caledonia will be responsible for snowplowing and maintenance of the Roadway, until the land to the south of the right-of-way is developed. At such time the Village of Caledonia and the Village of Mount Pleasant will meet to agree upon how to allocate costs going forward.
