June 10, 2025**

**1 - Order**

Meeting called to order by Trustee McManus at 5:01 p.m.

**2 – Roll Call**

**3 – Approval of Minutes from May 13, 2025**

Motion to approve the Minutes from May 13<sup>th</sup>, 2025, made by Tom Dovorany. Seconded by Michael Lambrecht. Motion carried unanimously.

**4 - Public comment –**

The following people appeared to speak before the Committee:

Village President explained that he wants to have an event in 2026 at Crawford Park that combines our departments efforts and includes a car show/beer garden/community engagement separate from the event at Franksville Park.

**5 – New Business**

**A. Review and Discuss Crawford Park Phase IV**

Staff presented the remaining phases at Crawford Park in order to follow the Master Plan. Staff also explained that a recommendation for a budget capital improvement request should come from this committee by the July meeting for the August Budget presentation. Lengthy discussion amongst the committee occurred regarding the parking lot/road, replacing playground equipment to attract families, and improving the area between the ball diamonds. Discussion to include multiple aspects of the project in 2026 and having a larger budget request occurred. Crowd funding and grant acquisition were discussed as well to offset the costs. Ultimately the committee wanted to see a more detailed cost estimate of items in order to make an informed decision. Staff was directed to bring that back to the July meeting.

**6 – Continuing Business**

**A. Review and Discuss Possible Disc Golf Opportunity for Gorney Park**

Staff presented a memorandum on the concept of Disc Golf at Gorney Park that was carried over from the previous meeting. Staff explained to ability to keep costs minimal by doing work in-house and coordinating with Root Pike Win for native plantings in the area. The Parks Staff has started discussions to get local businesses on board to sponsor a hole and get signage placed in their honor. Trustee Pierce added that
