NEW LAND USE CATEGORY Transitional light industrial

For low traffic industrial and employment uses including data centers.

I appreciate the efforts the Village of Caledonia has shown in creating a new zoning designation for data centers from M1 development category. But <u>Transitional Light industrial category is too broad</u>, and includes too many other development types.

Data Centers must have their own zoning category to address the needs and concerns of that very specific development. Especially because Data Centers are new and booming now. They are being rushed into communities who may not consider or know all the ramifications.

There are 4 types of data centers and an additional 4 tiers of development, from **limited protection and no redundancy** to **Fault tolerant sites with the highest level of fault tolerance and full redundancy**.

Should our zoning be tay lored to address some of these specific differences? To comment on the wording of the proposed New Land Use Category, it states <u>Suitable uses do not generate "excessive noise" or air pollution and avoid outside</u> <u>storage.</u>

Nothing in the description states what excessive is. I would like to see a maximum limit set in stone regarding db of noise. Some of the operations for data centers have been reported to make 55-85 db readings 24/7 due to generators, air exchangers and cooling systems.

Also, the description states **"low traffic"**. Be specific, what is low traffic? And other descriptions state **"light traffic"**, which is different than low traffic. Light traffic is described very differently: **"Truck traffic and heavy equipment use are "limited" with most transportation involving smaller delivery vehicles."**

Limited to what? Is this category using low traffic and light traffic interchangeably?

The proposed zoning allows small scale assembly and production. If there are 12 low traffic facilities, isn't this the same as a larger one. And even if there are there are only two assembly/production businesses, don't we want them to be successful and be able to expand as needed, as they would be allowed to do in a TIF or other M zoning district. If you allow the business to grow, before you

know it, there is more traffic than originally promised by the zoning. It is hard to say no to additions to a successful business in this zoning who wants to grow beyond the zoning description!

And of course there are words in this description like "typically" have minimal noise, odor, vibration or emission and "often" facilities are smaller and less intensive when compared to heavy industrial uses.

<u>Then the most unusual statement</u>: that light production characteristics **are less demanding in terms of power and resource consumption**....this is not a category in which a data center should be included.

This New Land Use category should be for Data Centers (ONLY)

Specific constraints should be put on decibels running 24/7 and traffic. Buffer zones should be specific, not arbitrary, for example .2 miles from any residential property line. Safety of environmental corridors should be guaranteed.

Asking for a specific zoning <u>category for data centers is more forward thinking</u> than the mixed use zoning category proposed. It also lets the village control the use of the land they are rezoning for data center use.

Looking down the road, as data centers have been shown to have a 10 – 15 year life, if the data center closes the land can be rezoned at that time for what is appropriate at that time. The Village board has more to say about the next type of development than just letting the mixed use suggested develop.

The proposed **multi use zoning category** will allow some of what is now M1 development to be established in an area that would have never allowed that type of development, if it weren't for the excitement of getting a Data Center in Caledonia.

Planning for a data center, and planning for light development have two very different concerns for the village. Keep M1 for your light development and keep data centers in their own category.

ORDINANCE NO. 2025-05 VILLAGE OF CALEDONIA

AN ORDINANCE ADOPTING AN AMENDMENT TO THE MULTI-JURISDICTIONAL COMPREHENSIVE PLAN FOR RACINE COUNTY: 2035 AS IT PERTAINS TO THE VILLAGE OF CALEDONIA UNDER SECTION 13-2-1 OF THE VILLAGE'S CODE OF ORDINANCES BY CREATING SECTION 13-2-2(W) ADDING AN AMENDMENT TO THE VILLAGE'S COMPREHENSIVE PLAN, CREATING AND DEFINING A NEW LAND USE CATEGORY, TRANSITION LIGHT INDUSTRIAL; VILLAGE OF CALEDONIA, OWNER

The Village Board of the Village of Caledonia, Racine County, Wisconsin, ordains as follows:

1. That pursuant to Section 61.35 of the Wisconsin Statutes, the Village of Caledonia is authorized to prepare and adopt a comprehensive plan as defined in Sections 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes.

2. That the Village Board, by the enactment of Ordinance No. 2009-07, created Section 13-2-1 of the Municipal Code of Ordinances and formally adopted the document titled "A Multi-Jurisdictional Comprehensive Plan for Racine County: 2035" as the Village Comprehensive Plan, and incorporated said plan into Section 13-2-1. The Village Board subsequently created Section 13-2-2 to track approved amendments to the Plan.

3. The Village published and posted a Class 1 30-day public notice and held a public hearing regarding the plan amendment on January 27, 2025.

4. That the Plan Commission, by majority vote of the entire Commission, at a meeting held on January 27, 2025, after a public hearing, adopted Plan Commission Resolution PC2025-01, recommending adoption of an ordinance amending the Comprehensive Plan by creating and defining a new land use category, Transition Light Industrial, for the purpose of providing opportunities for low traffic industrial and employment uses including data centers as part of the Comprehensive Plan as adopted by the Village Board.

5. The Village Board of the Village of Caledonia hereby adopts the proposed Comprehensive Plan amendment for the Village of Caledonia, for the following reasons:

1

- a. This Land Use category can provide a buffer between heavy industrial areas and less intense land use categories.
- b. This land use category provides opportunities for light industrial uses with minimal noise, pollution, and/or traffic impacts without the environmental impacts of more intense industrial uses and can help maintain the Village's character.

6. That Section 13-2-2(w) of the Municipal Code for the Village of Caledonia be, and hereby is, created to read as follows:

"(w) Transition Light Industrial

Transition Light Industrial areas provide opportunities for low-traffic industrial, and employment uses. Predominant uses are data centers, contractor establishments, and small-scale assembly or production. Appropriate uses do not generate excessive noise or air pollution or require outdoor storage. Open space with landscaping that creates effective visual buffers, reduces noise, and environmental protection on the site will encompass the business. Trails and passive parks are also appropriate.

DESIGN CHARACTERISTICS

Industries and businesses should incorporate large open spaces and include the following characteristics:

• Industries and businesses will operate within environments incorporating large open spaces, establishing forests, or thickly vegetated buffers, and ensuring effective visual screening from roads and adjacent developments.

• Buildings will maintain heights that transition appropriately to less intense residential uses.

• Noise-generating activities and outdoor operations will be separated from residential areas by buildings, berms, and vegetative buffers.

• Developments will include large, wooded buffers, berms, and setbacks from adjacent residential uses and sensitive environmental or water supply areas."

7. The Village Clerk is directed to send a copy of this ordinance and the plan amendment to the parties listed in Section 66.1001(4)(b) of the Wisconsin Statutes.

8. That after a sufficient number of land use plan amendments have occurred, the Village Clerk shall cause the land use map of the Comprehensive Plan to be updated to reflect the amendment herein.

9. That this ordinance shall take effect upon the day after posting or publication in accordance with ordinance and applicable law.

WHEREAS, the Village of Caledonia plans to build an access road as part of the Crawford Park Phase III expansion project; and

WHEREAS, We Energies has provided the legal documentation included hereto as Exhibit A for the recording of a 12' underground distribution easement in Crawford Park to accommodate the relocation; and

WHEREAS, the President and Clerk of the Village need to execute the Distribution Easement pending a legal review in order to allow it to be recorded; and

NOW, THEREFORE, BE IT RESOLVED by the Caledonia Village Board that the Underground Distribution Easement as set forth in Exhibit A, which is attached hereto and incorporated herein by reference, is approved subject to legal review and that the Village President and Village Clerk are authorized to execute said Distribution Easement after authorized by the Village Attorney.



For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, VILLAGE OF CALEDONIA, hereinafter referred to as "Grantor", owner of land, hereby grants and warrants to WISCONSIN ELECTRIC POWER COMPANY, a Wisconsin corporation doing business as We Energies, hereinafter referred to as "Grantee", a permanent non-exclusive easement upon, within, beneath, over and across a part of Grantor's land hereinafter referred to as "easement area".

The easement area is described as strips of land 12 feet in width being a part of the Grantor's premises located in the **Southeast 1/4 of Section 20**, **Township 4 North, Range 23 East,** Village of Caledonia, Racine County, Wisconsin; said premises being more particularly described in that certain Trustee's Deed recorded in the office of the Register of Deeds for Racine County, Wisconsin as Document No. 2405004.

The location of the easement area with respect to Grantor's land is as shown on the attached drawing, marked Exhibit "A", and made a part of this document.

1. **Purpose:** The purpose of this easement is to construct, install, operate, maintain, repair, replace and extend underground utility facilities, conduit and cables, electric pad-mounted transformers, mappole, electric pad-mounted transformers, mappole, electric, pad-mounted, transformers, mappol

and cables, electric pad-mounted transformers, manhole, electric pad-mounted switch-fuse units, electric pad-mounted vacuum fault interrupter, concrete slabs, power pedestals, terminals and markers, together with all necessary and appurtenant equipment under and above ground as deemed necessary by Grantee, all to transmit electric energy, signals, television and telecommunication services, including the customary growth and replacement thereof. Trees, bushes, branches and roots may be trimmed or removed so as not to interfere with Grantee's use of the easement area.

- 2. Access: Grantee or its agents shall have the right to enter and use Grantor's land with full right of ingress and egress over and across the easement area and adjacent lands of Grantor for the purpose of exercising its rights in the easement area.
- 3. Buildings or Other Structures: Grantor agrees that no structures will be erected in the easement area or in such close proximity to Grantee's facilities as to create a violation of all applicable State of Wisconsin electric codes or any amendments thereto.
- 4. Elevation: Grantor agrees that the elevation of the ground surface existing as of the date of the initial installation of Grantee's facilities within the easement area will not be altered by more than 4 inches without the written consent of Grantee.
- 5. Restoration: Grantee agrees to restore or cause to have restored Grantor's land, as nearly as is reasonably possible, to the condition existing prior to such entry by Grantee or its agents. This restoration, however, does not apply to the initial installation of said facilities or to any trees, bushes, branches or roots which may interfere with Grantee's use of the easement area.
- 6. Exercise of Rights: It is agreed that the complete exercise of the rights herein conveyed may be gradual and not fully exercised until sometime in the future, and that none of the rights herein granted shall be lost by non-use.
- 7. Binding on Future Parties: This grant of easement shall be binding upon and inure to the benefit of the heirs, successors and assigns of all parties hereto.
- 8. Easement Review: Grantor acknowledges receipt of materials which describe Grantor's rights and options in the easement negotiation process and furthermore acknowledges that Grantor has had at least 5 days to review this easement document *or* voluntarily waives the five day review period.

- 9. Indemnification and Hold Harmless: In consideration of the foregoing grant, it is understood that during the time said facilities are located on the premises of the Grantor pursuant to this grant, Grantee will indemnify, save, and hold harmless the Grantor, its successors and assigns, from any and all claims, liabilities, losses, costs, damages or expenses for injury or death of any person and any damages to property arising out of Grantee's exercise of any of its rights under this easement; excepting, however, 1) any claims, liabilities, losses, costs, damages or expenses arising out of negligence or willful acts on the part of the Grantor, its successors and assigns, employees, agents and invitees; 2) any special, consequential or indirect damages, including but not limited to, loss of profit or revenue, and diminution in value; and 3) any environmental claims, liabilities, losses, costs, damages or expenses not directly caused by the construction or operation of said facilities.
- 10. Assignment of Rights: This easement and its rights may be assigned to affiliated entities under common control of Grantee but may not be assigned or shared with third parties unless for the purpose of providing for electric service without the approval of Grantor and such approval shall not be unreasonably withheld. It is not the intention of either the Grantor or the grantee that other persons or parties shall acquire any rights to enforce or benefit from or through this Easement unless such rights relate to the purpose of providing for electric service.
