- ii. Root River / Bridge Investigations

This item was an agenda request from the August Meeting. The Commission would like to have a base line of the Root River prior to the Waukesha Water Diversion being done upstream in the Root River. This will identify areas with potential problems and give recommendations.

As far as the 3 bridges over the Root River, they are inspected by a consultant as a requirement of the State of Wisconsin DOT every 2 years. The inspections were performed on September 12th 2016.

In the past the Commission has worked with Hey & Associates for a Ravine Study. We could contact them for an estimate or we could prepare an RFP for the project.

Commissioner Mielke moved to prepare a Request For Proposal (RFP) for an Erosion / Natural Resource Study for the Root River in the Village of Caledonia. Seconded by Commissioner McAteer. **Motion carried.**
