Plan Commission recommended approval. Chris Benish, representative for the applicant was in the audience and said he kind of understood the conditions and knew they had till the end of the year to fulfill some of them. Banner signs were discussed and it was stated that they are not allowed in the village. They also discussed that a US flag cannot be used as a sign per code either. Benish asked what they needed to do to allow more cars in the area instead of going back to day one of the agreement. President Bradley explained that the Plan Commission was looking for some kind of structure regarding how the automobiles are displayed.
